## Chapter 1 INTRODUCTION

The Barrington Area Community Analysis presents a comprehensive overview of 60010, describing residents and resources through secondary sources of information.

Topics include population size, age, race/ethnicity, gender, family structure, income and poverty, education, employment, housing, births, deaths, health status including morbidity, health behaviors, disability, health resources, health care utilization, social indicators, and crime and violence.

The major sources of information for the Community Analysis are the *2010 Census of Population and Housing*, *2008-2012 American Community Survey*, other U.S. Census updates, vital statistics collected by the Illinois Department of Public Health, Behavioral Risk Factor Survey, and social and economic indicators primarily from state and regional agencies.

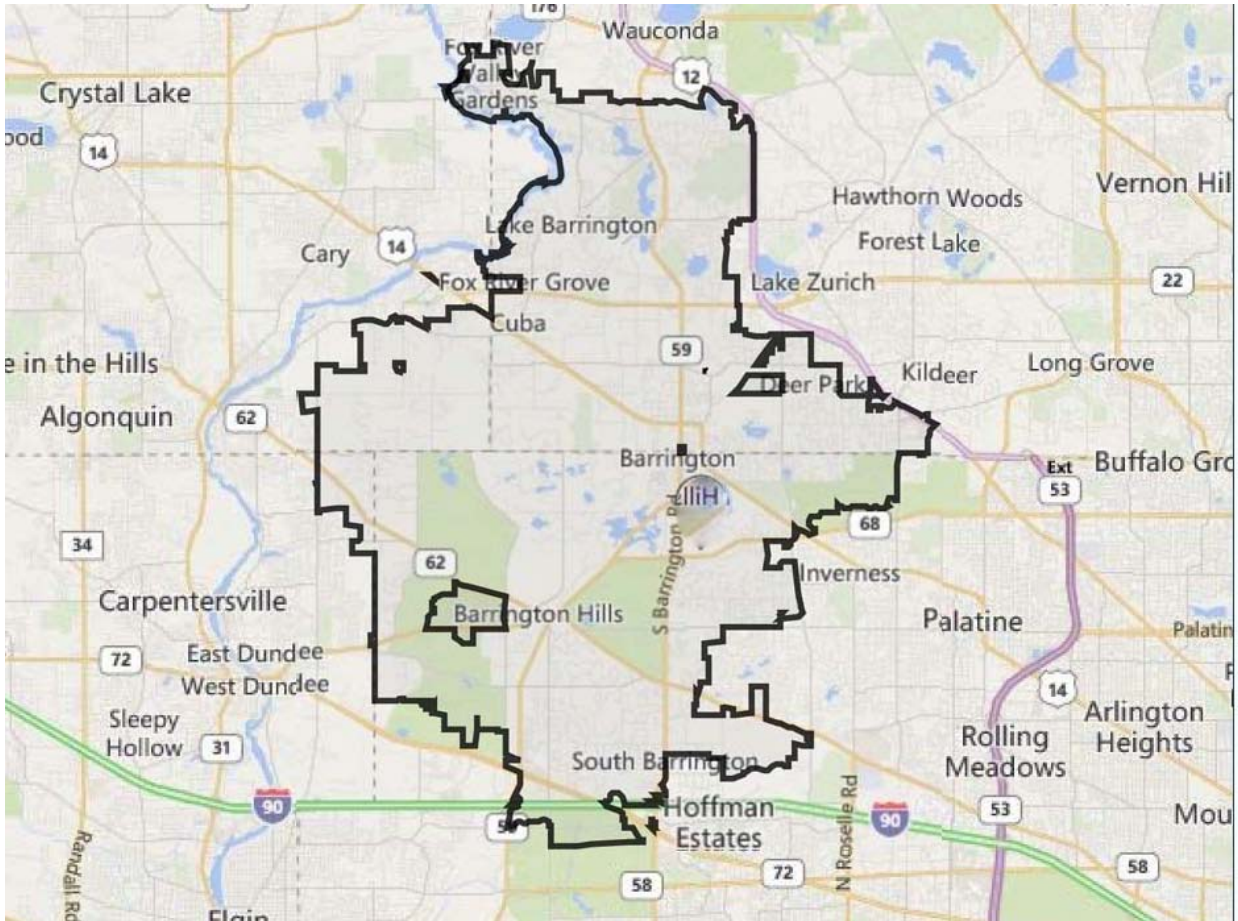
The Barrington Area Community Analysis relies quite heavily upon recent data from the American Community Survey (ACS). Historically, the Census Bureau has collected detailed demographic, housing, social and economic data every ten years, selecting a sample of one in six households to complete the detailed "long form." Desiring more timely information, the Census Bureau has replaced the decennial "long form" used in 2000 with the ACS, which collects the same type of data every year. Three million households across the nation are surveyed annually, using a multi-stage sampling technique and a varying percentage of households depending on an area's size. Because the sample is limited, years are combined for greater reliability. This report primarily relies on 2008-2012 data for 60010 so as to reflect the most recent data.

This report was prepared for the Healthier Barrington Coalition, a partnership of 25 Barrington area organizations working together to improve the quality of life for residents of the Barrington area.

The Coalition has regularly conducted assessments of needs. Seven household surveys have been sent to area residents and analyzed every three years since 1996 for resident needs, followed by actions to improve the quality of life. This is the first community analysis, adding further depth to an understanding of the community.

This report was produced by Joel Cowen, MA, and Karen Lytwyn, MPH, retirees from Health Systems Research at the University of Illinois College of Medicine at Rockford, which conducted the first six household surveys.

## Chapter 2 POPULATION

### Introduction

Census Bureau zip codes used in this report are actually Zip Code Tabulation Areas (ZCTAs), first developed by the Census Bureau for tabulations in 2000. They differ slightly from U.S. Postal Service zip codes which change boundaries regularly. Barrington also hosts zip code 60011 for post office boxes.

### Population Characteristics

The 2010 Decennial Census of all 60010 residents on April 1, 2010 gave a count of 44,095. The American Community Survey for 2008-2012 yielded an estimate of 44,209 for the five-year period. From 2000 - 2010, zip code 60010 grew 10.7% from 39,819 to 44,095, slightly faster than the 6.7% growth in the prior decade from 1990-2000. Growth from 1980 to 1990 was more rapid at 34%. (Table 2.1)

Barrington is the largest village in the zip code with a 2012 estimated population of 10,351. Somewhat smaller are Lake Barrington (4,973), South Barrington (4,656) and Barrington Hills (4,275), followed by Deer Park (3,221) and North Barrington (3,042). Smaller are Port Barrington (1,512) and Tower Lakes (1,278). (Table 2.2)

Numerically, the largest 2000 - 2012 gains took place in South Barrington (+896) and Port Barrington (+724). In terms of percentage gain, Port Barrington (+91.9%) and South Barrington (+23.8%) also were the leaders. Only Tower Lakes lost population over the twelve-year period. (Table 2.2)

Based on the 15,910 residential addresses within 60010, 59.4% are in Lake County and 36.2% are contained in Cook County. Fewer 60010 residences are in McHenry (3.9%) or Kane (0.4%) Counties. (Table 2.3)

Barrington contains about one-fourth of 60010 addresses, followed by 17.6% in Lake Barrington and 9.5% in Barrington Hills. The 60010 address proportions are Deer Park and North Barrington (7.3% each) and South Barrington (7.1%) (Table 2.4)

Entirely within 60010 are Barrington, Barrington Hills, Deer Park, North Barrington, Port Barrington, South Barrington, and Tower Lakes. Lake Barrington addresses are 96.3% in 60010. These eight communities are featured in this study. Smaller proportions of Inverness, Lake Zurich and Hoffman Estates are also within 60010. (Table 2.5)

Zip code 60010 contains 76.4 total square miles, of which 73.8 square miles are land and 2.6 square miles are water. The Village of Barrington is most dense with 2,235.3 persons per land square mile. Least dense with just 153.4 persons per land square mile is Barrington Hills. (Table 2.6)

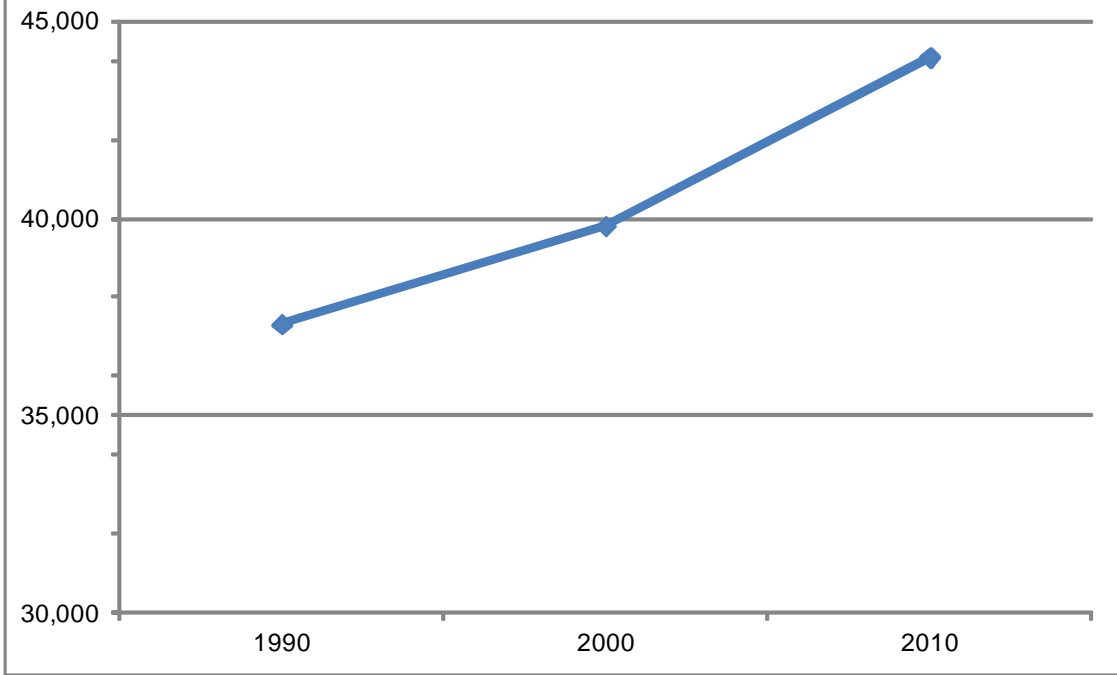

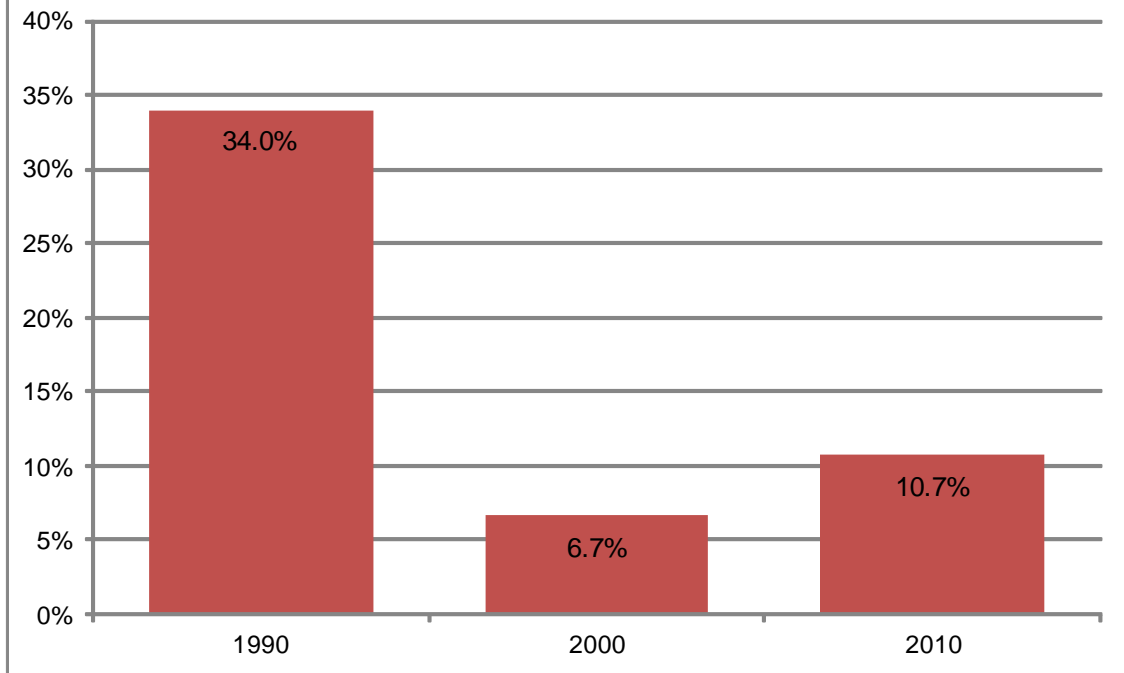

## Chapter 3 RACE, ETHNICITY, LANGUAGE, ANCESTRY

### Race/Ethnicity

According to the 2010 Census, the racial composition of 60010 was 88.4% white, 8.4% Asian and 0.8% black. Asian is the second largest racial group in the Barrington area, accounting for one in twelve local residents. Other categories total less than one percent, while 1.6% of local residents named more than one race. (Table 3.1)

All racial groups experienced growth from 2000 to 2010 led by Asian (+104.6%) which doubled during the decade. Individuals designating multiple races also doubled (+112.1%). The Barrington area became increasingly diverse as the zip code grew by 10.7%, but the white population added only 4.7%, less than half the overall rate. White non-Hispanics grew by just 3.6%. (Table 3.1)

Hispanic is considered an ethnic identity by the Census Bureau, not a race. The term Hispanic was first adopted for the 1980 Census. The 2010 Hispanic count stood at 1,435, about double (+84.4%) the 2000 count of 778. (Table 3.1)

Racially, seven of ten (71.4%) Hispanics list themselves as white. The next largest racial designations are "other" (19%) and multiple races (7.5%). (Table 3.2)

Broken out by origin, the 2010 Hispanic population identified themselves as Mexican (58.1%), Puerto Rican (8.7%), Cuban (6.4%) and "other" (26.8%). (Table 3.3)

The largest Asian group is Asian Indians, constituting 38% of all Asians and 3.2% of the entire 60010 population. Asian Indians grew 127.8% from 2000 to 2010, the fastest growing of the Asian groups. Also with a significant 2010 presence were Chinese (818), Korean (637), Filipino (315) and Japanese (217) persons. (Table 3.4)

### Foreign Born

Of the civilian noninstitutionalized 60010 population, 86.5% were born in the United States and 13.5% were foreign born. For the 5,959 persons born abroad, nearly two-thirds (72.4%) have become citizens, a proportion well above the nation at 44.3%. Of those born outside the U.S. over half (51.2%) were born in Asia, followed by Europe (33.2%) and Latin America (12.8%). (Table 3.5)

Arranged by nation of birth, the leading nations for the foreign born are India (15.3%), China (9.3%), Poland (8.1%), Mexico (6.6%), Philippines (6.3%) and Germany (5.3%). (Table 3.6)

### Ancestry

The Census Bureau collects information on the ancestry of individuals which is their self-identification of heritage or nationality of descent. Respondents are allowed to name up to two ancestries, although ancestry identification has been declining over time. The two leading ancestries locally are German (25.5% designating) and Irish (17.5%). Other ancestries named by more than five percent of residents were Italian (12.5%), Polish (11.5%) and English (9.9%). As compared to the nation, 60010 has substantially more German, Irish, Polish and Italian residents. (Table 3.7)

## Language Spoken

The 2008-2012 ACS asked persons aged five and older whether they speak a language at home other than English. Of the 42,142 Barrington area residents aged 5+, 82.5% speak only English at home, while one in six, or 7,376 persons speak some other language at home. The leading non-English languages are Indo-European (9.5%), Asian (4%) and Spanish (3.6%). Indo-European includes most languages of Europe plus the Indic languages of India. (Table 3.8)

Most residents, even many who speak another language at home, speak English very well, 98.6% overall. However, those who do not speak English very well increases with age reaching 3.2% among persons aged 65+. The Census Bureau rates 340 (2.1%) households as linguistically isolated” meaning that no one in the home 14+ speaks English “very well.” (Table 3.9)

The most common non-English languages found in the Barrington area are Polish (828), Chinese (752), German (573), Hindi (409) and Greek (399). (Table 3.10)

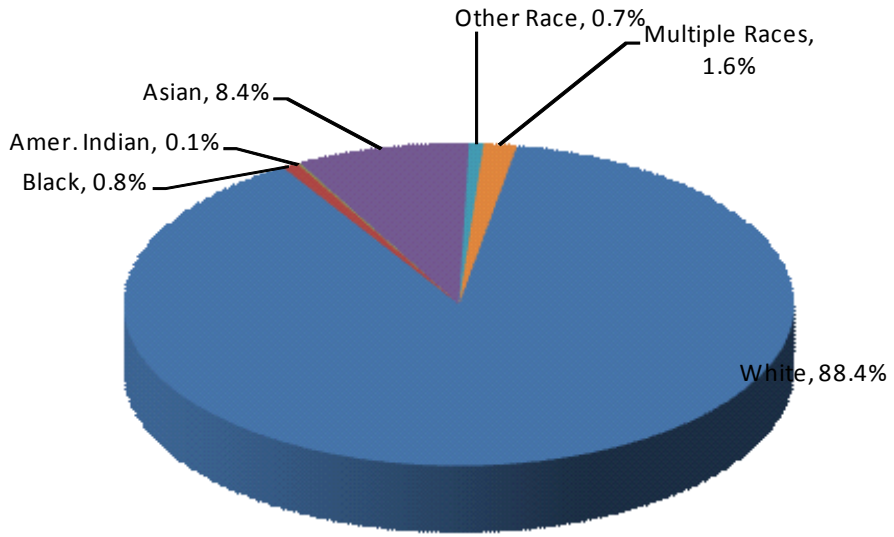

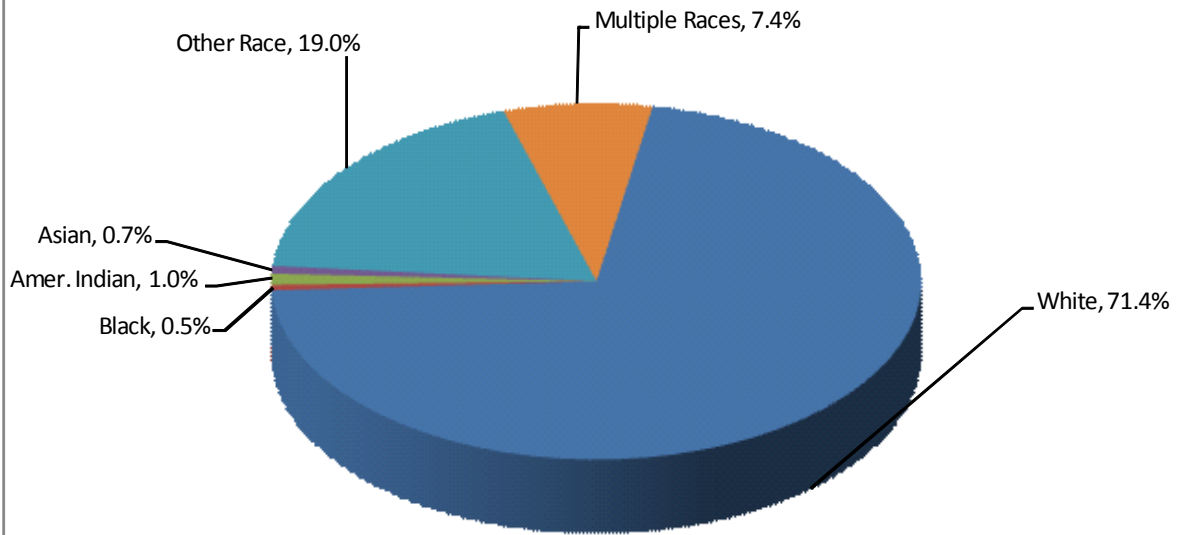

## Chapter 4 AGE AND GENDER

### Age

The age structure of zip code 60010, generally, is older than the nation. One in five (19.2%) 60010 residents is aged 45-54, compared to just 11.8% of the nation's population. Locally, the percent of individuals for all age groups 45 and older is higher than the U.S. The proportion of children in 60010 is a bit higher (25.8% than for the U.S. (24%). (Table 4.1)

The 60010 median age in 2010 was 45.8 years compared to 37.2 for the U.S. Locally the median age rose 4.5 years from 2000 to 2010, substantially higher than the 1.9 year increase for the nation. (Table 4.2)

From 2000-2010 the fastest growing age group was persons 85+, which grew 161.8%, followed by those aged 65-74 (+61.9%). Three age groups lost population during the decade: 35-44 (-20.1%), 25-34 (-18.5%), and children 0-5 (-17.7%). (Table 4.3)

For 2010, the median age for women in 60010 was 41.5, just 0.4 years older than males. The minority population is younger than the white non-Hispanic group. The black median age in 2010 was 38.5, with Hispanics at 26.4 and Asians at 35.4, compared to 47.2 for the white non-Hispanic group. All races/ethnicities except Asian aged since the 2000 Census. (Table 4.4)

### Gender Ratio

Overall, zip code 60010 contains 21,677 males and 22,418 females for a gender ratio of 96.7 males per 100 females. Males are the majority in most younger age groups. However, in senior cohorts, the gender ratios become increasingly lower with a ratio of 39.5 at 90 and older. (Table 4.5)

Among race/ethnic groups, the highest gender ratio is found among Hispanics (100.1), while the lowest is among Asians (90.3). (Table 4.6)

### Age for 60010 Communities

The youngest median age among 60010 communities is found in Port Barrington (38.9), while the oldest community is Lake Barrington (53.6 years). Tower Lakes (31%) contains the highest proportion of children aged 0-17, with Lake Barrington, by far, having the highest level (29.5%) of seniors aged 65+. (Table 4.7)

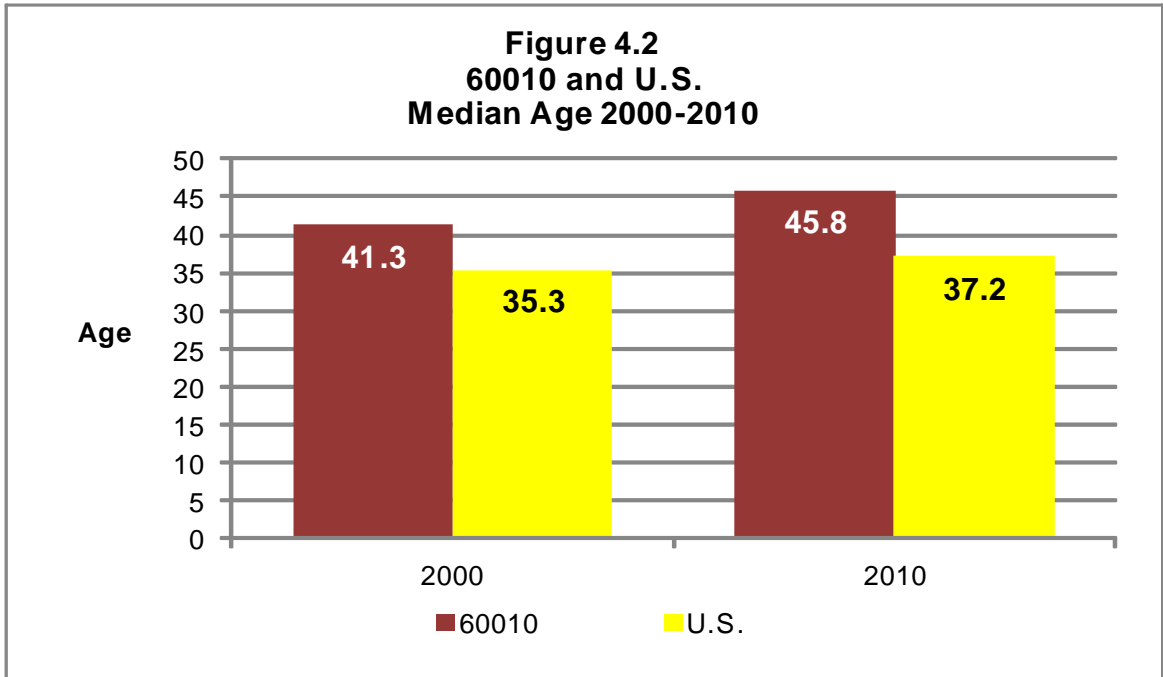
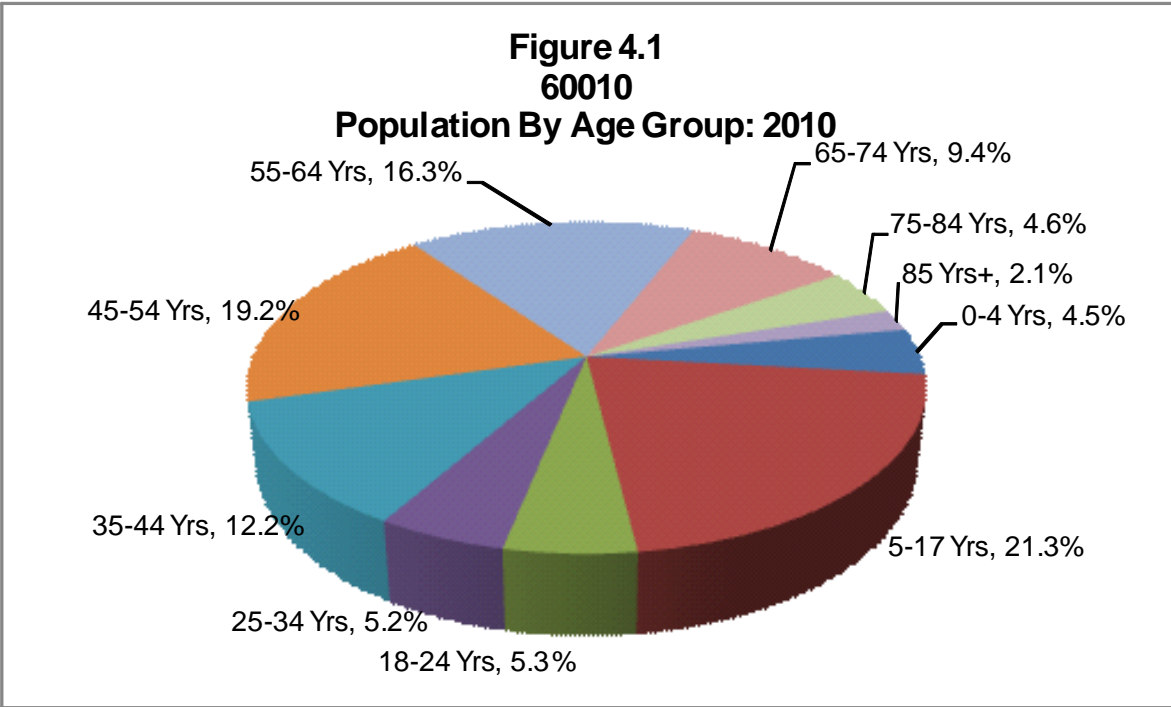

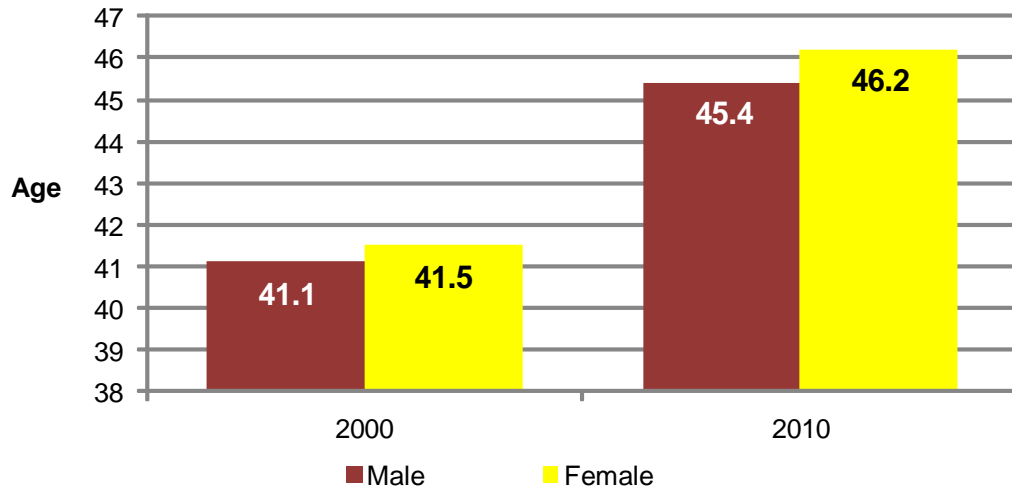

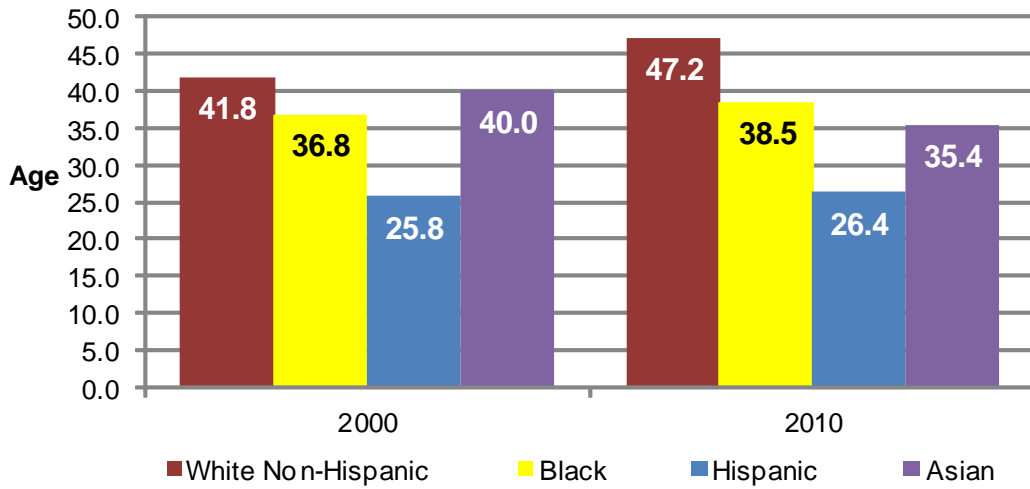

## Chapter 5 HOUSEHOLD CHARACTERISTICS AND MARITAL STATUS

### Household Relationships

In 2010, almost all (99.6%) of zip code 60010 residents lived in a household, which is defined by the Census Bureau as “one or more persons occupying a housing unit.” The majority of persons living in a household belong to a family (two or more related persons living together). In 60010, over one-third (36.5%) of persons living in a household in 2010 were the householder, slightly lower than state and national levels, while about one in four was a spouse. Almost one-third (32.6%) of those in a household was a child, slightly higher than Illinois (30.7%) and the U.S. (29.5%). (Table 5.1)

### Household Structure

In 2010, the number of 60010 households stood at 16,050. About eight of ten (79.1%) households are family households, much higher than the 65.8% for Illinois and 66.4% for the nation. Over three in ten (31.5%) are married couple with children households, well above the state (21%) and U.S. (20.2%), but down appreciably from 36% in 2000. Very few single parent households (7.6%) are present in 60010, of which 68.3% are headed by a single female. (Table 5.2)

The average household size was 2.74 persons in the last Census, higher than both state (2.59) and U.S. (2.58) averages. The average family has 3.13 persons. Both average household and family size fell from the 2000 Census (Table 5.3)

### Household Settings for Children

Almost nine in ten (87.8%) of 60010 children under age 18 lived in a married couple family in 2010, far higher than state (63.2%) and national (61.3%) proportions. Living with a single female parent are just 6.3% of local children, while 2.7% reside with a single male parent. The level of children living with a single parent is well below the state and nation. (Table 5.4)

Locally, 234 children (2%) were living in a home where a grandparent was the householder in 2010, below state (7.6%) and U.S. (7.9%) proportions. Hispanic children are most likely to live with a grandparent, standing at 4.3%, but less than half the Illinois and U.S. levels for Hispanic children. (Table 5.5)

### Household Settings for the Elderly

The vast majority (98.1%) of persons aged 65 and older in 60010 lived in a household in 2010, primarily as a householder or spouse. One in five (21.6%) lived alone, primarily women. Just 137 elderly lived in group quarters. (Table 5.6)

### Household Characteristics for 60010 Communities

Among 60010 communities, Port Barrington (39.8%) and Tower Lakes (39.5%) reveal the highest proportions of married couple with children households. Although a small proportion, Barrington has the highest level of single mother households (4.5%). The highest average household size (3.16) is in South Barrington which contains both the largest average household (3.16 persons) and average family (3.33). (Table 5.7)

### Unmarried Partner Households

Since the 2000 Census, the Census Bureau has provided information about unmarried partner households, defined as “a household in which the householder and his or her partner are not legally married or participating in a common law marriage.” 60010 contained 448 unmarried partner households according to the 2010 Census. Of these, 80.6% are male/female households, with 11.4% containing persons who are both male, and 8% in which the individuals are both female. The area has a far higher proportion of same sex partners than found in the state or nation. (Table 5.8)

### Persons in Group Quarters

The number of 60010 residents living in group quarters in 2010 was just 166, with all but nine living in nursing homes. In 2000, the area contained no individuals living in group quarters. (Table 5.9)

### Marital Status

Among 60010 residents aged 15 and older, 20.7% are never married, 67.2% are married, 7.4% divorced or separated, and 4.7% widowed. The area contains elevated levels of married individuals compared to the state (49.1%) and nation (49.8%). A higher proportion of males than females are never married, while many more local women (6.7%) than men (2.6%) are widowed, due to female longevity. (Table 5.10)

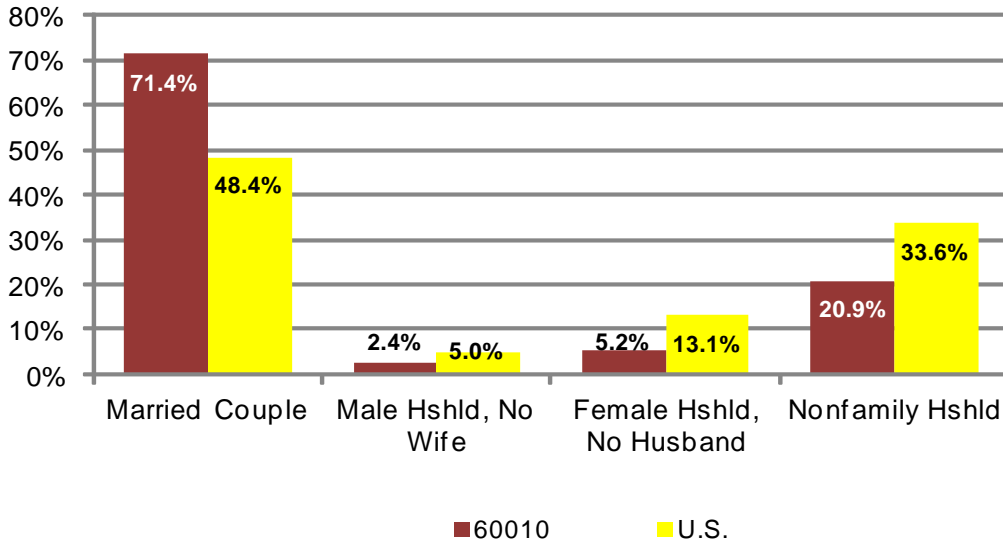

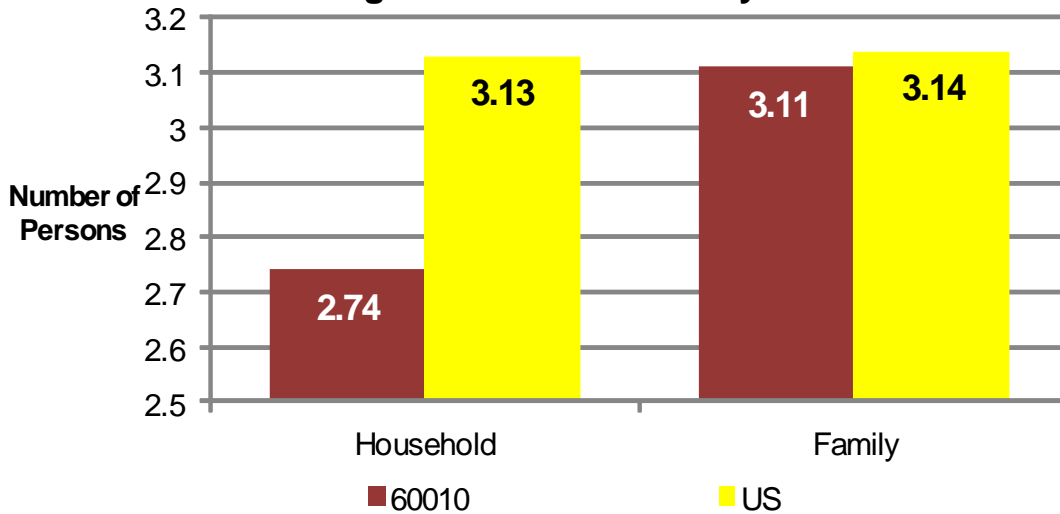

## Chapter 6 HOUSING

### Housing Units and Occupancy

According to the 2010 Census, 60010 contained 17,154 housing units, of which 93.6% were occupied and 6.4% were vacant. Homeowner units revealed a 2.3% vacancy rate, compared to 11% of rental units. (Table 6.1).

From 2000-2010, the population grew by 10.7% while housing unit expansion reached 18.4%. With housing expansion exceeding growth, along with the recession, the number of vacant units rose by 14%. (Table 6.2)

### Tenure

From 2000-2010, the proportion of renter-occupied units rose from 8.2% to 10.3%. The proportion of owner-occupied units, 89.7% in 2010, was well above the state (67.5%) and nation (65.1%). (Table 6.3)

Housing tenure by race/ethnicity in 2008-2012 reveals that fewer Hispanic households are home owners (58.6%) compared to black (100%), white non-Hispanic (92.3%) and Asian (90.9%) households. (Table 6.4)

Home ownership peaks for 45-54 year-old householders at 95.9%, although 55-64 (94.7%) and 65-74 (94.3%) recorded similar proportions in 2008-2012. (Table 6.5)

### Other Housing Characteristics

92.5% of occupied structures are single family units, 96.7% for owner-occupied and 50.9% for renters. Only 3.6% of structures have 10 or more apartments. The 3.1% of owner-occupied units in structures with two or more units may be condominiums. (Table 6.6)

Single family homes experienced an expansion of 1,698 units from 2000 to 2008-2012 moving from 91.7% of units to 92.5%. However, the greatest proportional growth took place for structures with five or more units, which constituted 3.2% of structures in 2000 compared to 4.7% in 2008-2012, moving from 474 to 762 during the period. (Table 6.7)

Homes in the Barrington area are very large compared to the state and nation, a median size of 8.3 rooms (5.6 for the state and nation). Bathrooms and utility rooms are not counted. Owner-occupied homes recorded a 2008-2012 median of 8.5 rooms, while renter-occupied units were much smaller at 4.8 rooms. (Table 6.8)

The average owner-occupied unit is home to an average of 2.81 persons compared to 2.12 for renter-occupied units. The average for owner-occupied units is larger than the nation-2.68, while the local renter-occupied average is smaller than the U.S.-2.48. (Table 6.9)

The median year moved into the unit was 2000, according to the 2008-2012 ACS, 1999 for owner-occupied and 2005 for renter-occupied. (Table 6.10)

The median year that the unit was built was 1980 in the 2008-2012 American Community Survey, 1981 for owner-occupied and 1976 for renter-occupied. Housing is newer than the state (1967) and nation (1975). (Table 6.11)



The median value of owner-occupied units, according to 60010 residents in 2008-2012 was \$557,000, well above the nation at \$181,400. In 2000, the median value stood at \$396,200. (Table 6.12) Barrington Hills (\$888,000) exhibits the highest median value, followed closely by South Barrington (\$820,000) and North Barrington (\$764,000). (Table 6.17) Zillow reports a median for 2013 homes sold at \$410,450. (Table 6.15)

The median gross rent (cash plus utilities) in 60010 for 2008-2012 was \$1,383, up from \$992 in 2000. The U.S. stood at \$889. (Table 6.13) The Village of Barrington has the highest level of renter-occupied units (21.9%), with a median gross rent of \$1,319. (Table 6.17)

According to the Census reports of privately owned residential building permits, the number of permits fell substantially in 60010 from 249 in 2006 to just 23 in 2012. All 2005-2012 permits were for single family homes except in the Village of Barrington. During the 2005-2012 period, South Barrington (273) and Barrington (188) were the permit leaders. (Table 6.14)

The combination of elevated housing costs and household income resulted in the 2008-2012 burden of housing, 23% of income, being similar to the nation. (Table 6.16)

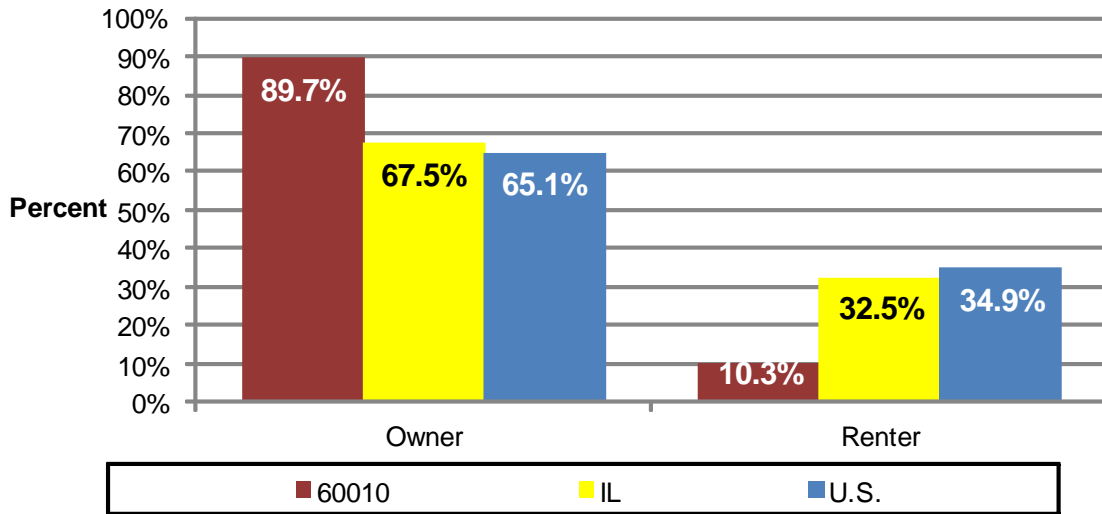

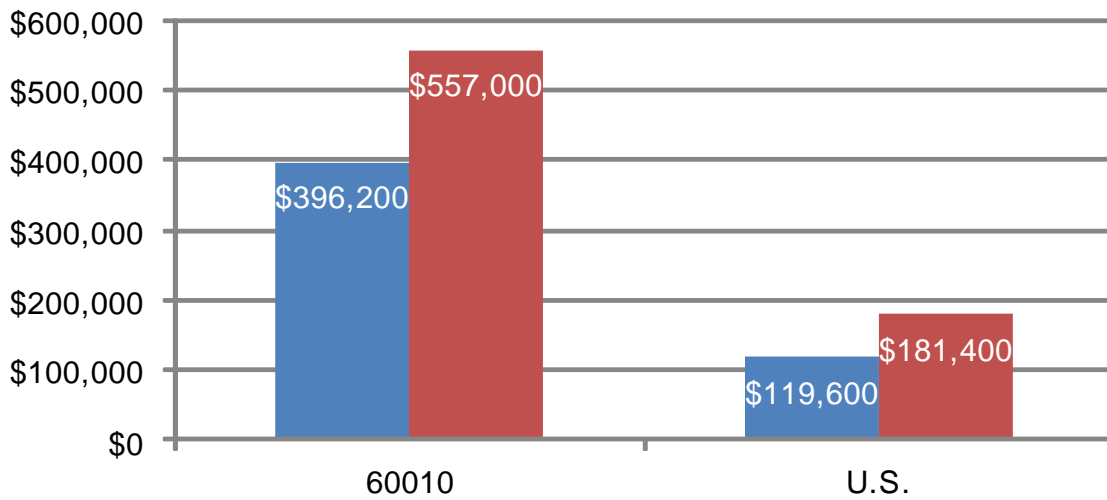

## Chapter 7 EDUCATION AND EMPLOYMENT

### Educational Attainment

97.4% of 60010 adults 25+ are high school graduates, exceeding both Illinois (87%) and the U.S. (85.7%) for 2008-2012. Bachelor's degrees have been obtained by 63.3% of 60010 residents 25+, about double the state (31.1%) and nation (31.6%). More than one-fourth (27.9%) of adults 25+ hold a graduate or professional degree, far above Illinois (11.8%) and national (10.6%) levels. (Tables 7.1, 7.2)

Educational attainment has grown in the past decade at all levels. Since 2000, bachelor's completion rose 4.2% and graduate degrees rose 3.3%. (Table 7.1)

By gender, more men have bachelor's degrees (69.7%) and graduate degrees (34.9%) than women (bachelor's-57.5%; graduate-21.5%), though the female levels are still relatively high. (Table 7.3)

Analyzed by race/ethnicity, 60010 Asians are best educated (high school-99.2%; bachelor's-82.4%). Attainment is lower for the black (high school-79.3%; bachelor's-38.6%) and Hispanic (high school-80.4%; bachelor's-48.2%) populations, although the Black and Hispanic levels exceed the general population for the state and nation. (Table 7.3)

Four-year high school graduation rates for the Barrington School District, 96% currently, are well above the state (83%) for recent years. (Table 7.4)

Overall private school enrollment for the population aged 3+ is 20.3%, similar to the Illinois proportion of 19% and a bit above the nation (16.7%). Private school enrollment is highest for preschool (65.8%) and graduate school (55.8%). (Table 7.5)

Greater education pays off in terms of earnings. For 60010 residents aged 25+ with a graduate degree, men earned \$105,816 and women \$73,661 for 2008-2012, almost triple the earnings of those whose highest level was high school. (Table 7.6)

### Employment

Of 60010 residents aged 16 and older, labor force participation (61.8%) is somewhat lower than Illinois (66.7%) and the U.S. (64.7%) for the period 2008-2012. While men (71.2%) participate at a rate similar to the state and nation, women (52.7%) are less likely than the state and nation to be in the labor force. Male labor force participation has declined over the past decade. (Table 7.7)

About two-thirds of local residents working are male. Unemployment for the period 2008-2012 averaged 3.9% in 60010, 4.7% for males and 3.2% for females. (Table 7.8)

The average local worker aged 16-64 works 40 hours a week, 43.5 for men and 35.7 for women. About one in five workers (19.1%) is employed less than 35 hours a week. (Table 7.8)

Among 60010 families (two or more related persons living together), nearly nine in ten (89.6%) are married couples. In just under half (47.6%) of married couple families, both the husband and wife are in the labor force, 29.2% have the husband in the labor force, 4.7% have just the wife in the labor force, while in 18.5% neither is in the labor force. However, when children are present, participation is 99.1% for one or the other, both work in 60.6% of families with children. (Table 7.9)

Though unemployment is relatively low in 60010, certain groups exhibit higher levels, including persons in poverty (36.2%), blacks (24.7%), those aged 20-24 (19.2%), individuals without a high school diploma (19.2%) and the disabled (19%). (Table 7.10)

Compared to the nation (25.4 minutes), 2008-2012 commuting time is quite high at 34.0 minutes for workers living in 60010. One of six workers (16.5%) spends an hour or more traveling to work, twice the national proportion. Somewhat higher levels use public transportation (7.5%) or work at home (9.2%) as compared to the U.S. (Tables 7.11, 7.12)

15.7% of 60010 workers are employed in their home community, half (51%) work in their home county, and 97.3% work in Illinois. The 2008-2012 ACS shows that one in four (25.1%) works in the City of Chicago. (Table 7.13)

In terms of occupation, 60% of 60010 workers classify themselves as “management or professional” well above the nation’s 35.9%. The leading industries of employment for local workers are “professional, scientific and management” and “educational, health and social services,” both at 19.6%, followed by “finance, insurance and real estate (12.3%). “Professional, scientific and management” and “finance, insurance and real estate” are found at nearly twice the U.S. level. (Table 7.14)

### Business Characteristics

County Business Patterns, a Census publication, reveals that in 2011, the 60010 zip code was home to 1,898 establishments with 19,314 employees, generating an annual payroll of \$1 billion. (Table 7.15)

The leading industry based on the number of establishments is “professional, scientific and technical services” with 396 or one in five (20.9%) establishments, followed by “health care and social assistance” (11.7%), retail trade (9.6%) and construction (9.1%). (Table 7.16)

When viewed at the six-digit NAICS level, 17 business types with 20 or more establishments are present in 60010. Most frequent are physician offices (9.7%), wholesale trade agent location (5.4%), management consulting sites (5.2%), insurance agent offices (4.8%) and offices of lawyers (4.6%). (Table 7.17)

Of the 1,834 firms in the Village of Barrington, 3.8% are Asian-owned and 28.9% are women-owned. The Village has high levels of wholesaling and retail sales relative to the nation. (Table 7.18)

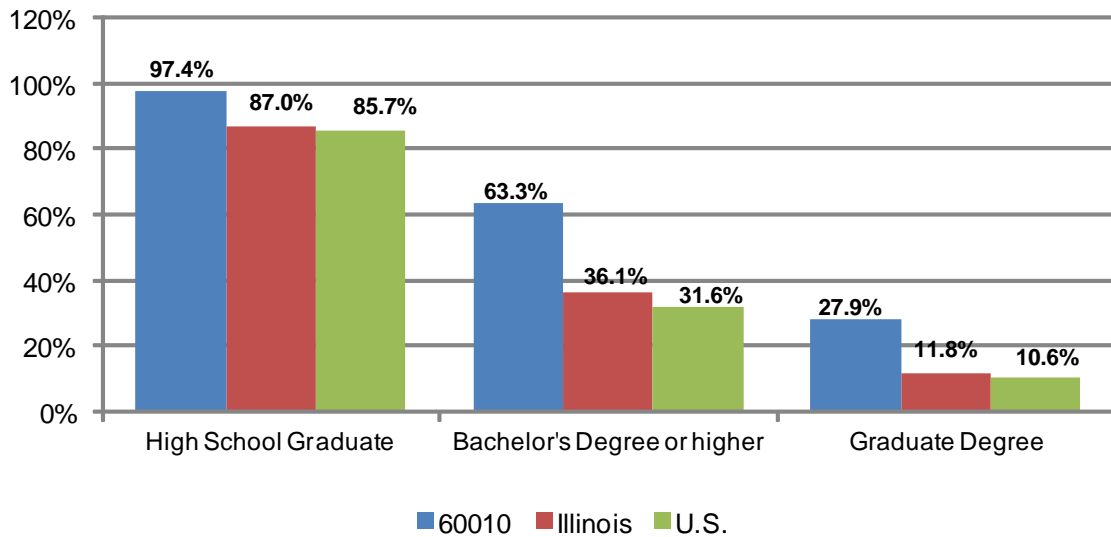

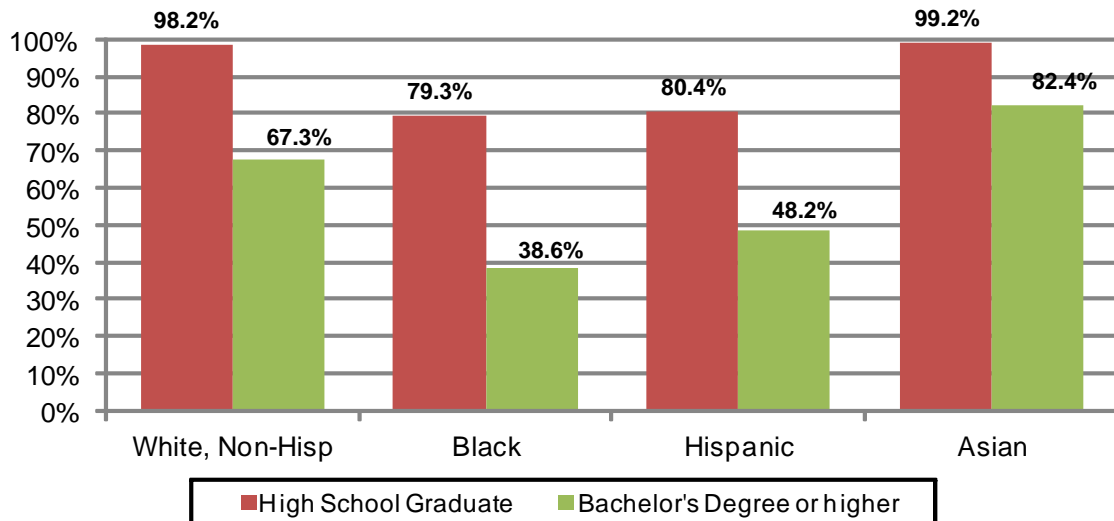

**Educational Attainment: 2008-2012**

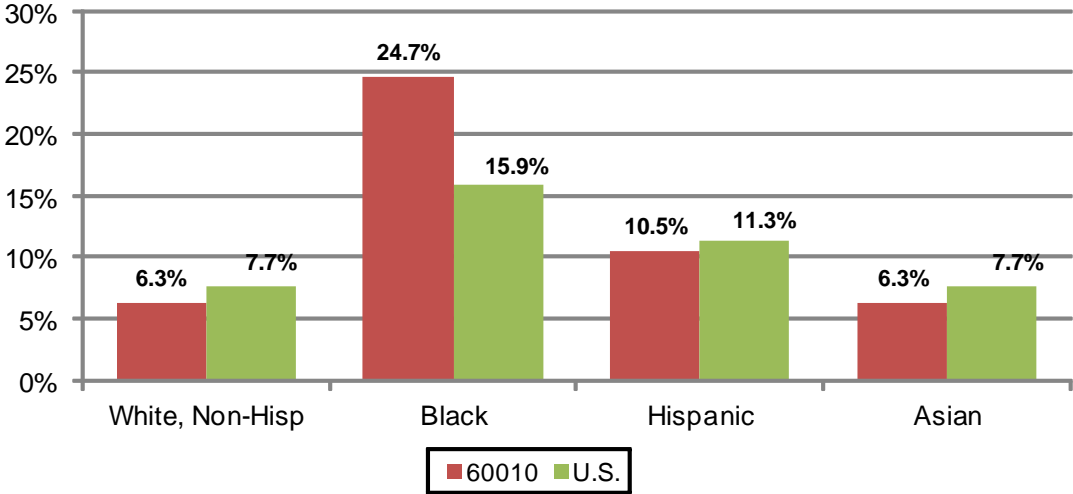


**Figure 7.2**

**by Race/Ethnicity: 2008-2012**

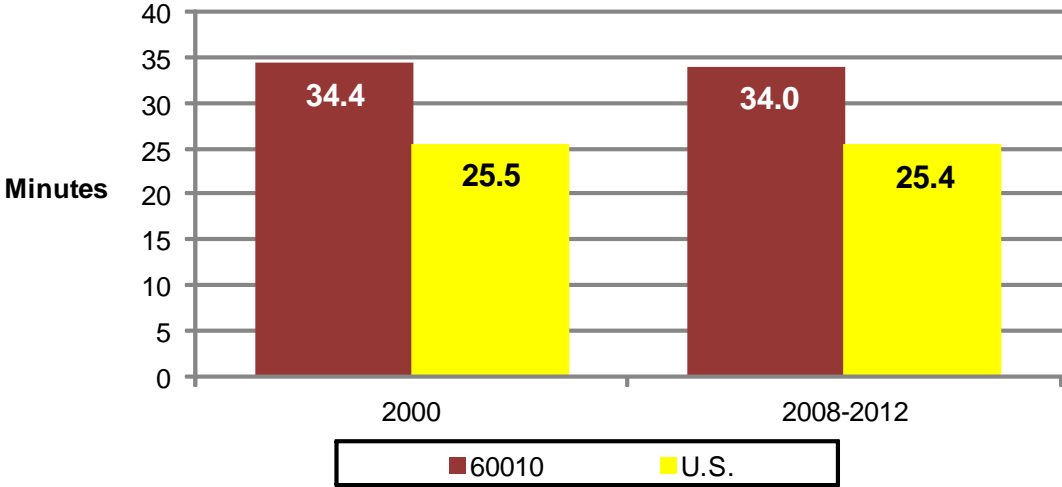




**Figure 7.3**

## Chapter 8 INCOME AND POVERTY

### Income

The 2008-2012 zip code 60010 median household income (\$120,117) was more than double the median for both the U.S. (\$53,046) and Illinois (\$56,853). From the 2000 Census to 2008-2012, the median household income for 60010 rose from \$110,470, a 8.7% increase, but much lower than the state (22%) and U.S. (26.3%) increases. (Table 8.1)

Local households headed by 45-64 year olds earned the most in 2008-2012 (\$152,153). 60010's youngest households reported the lowest median income at \$32,361. Median household income for all groups rose from the 2000 Census to 2008-2012, with the 25-44 year-old householders experiencing the largest increase. Among ethnic groups, the 2008-2012 median household income was highest for Asian households, standing at \$154,056, followed by white non-Hispanic households (\$120,334). Although still high, lower median household income was reported for black (\$94,115) and Hispanic (\$111,393) households. Median household income for all races/ethnicities rose from 2000 to 2008-2012, except for blacks, which declined by 7.8%. Asian households recorded the largest increase (+23.8%). (Table 8.2)

60010 families earn a median income (\$140,473) far higher than nonfamily households (\$54,655). The local 2008-2012 per capita income was \$65,640, more than double the state and national levels. Median income levels for all household types in 60010 are far above Illinois and the nation. The 60010 median for married-couple families (\$148,882) is more than double that for single female families (\$65,568). Per capita income locally stood at \$65,640. (Table 8.3)

Analysis of 60010 household types distributed by income categories shows that the largest proportion of both households (28.2%) and families (32.3%) earn in the \$200,000+ category. One-fifth of both area households and families earned between \$100,000 - \$149,000 in 2008-2012. About 12% of households and just 7.8% of families earned less than \$35,000. (Table 8.4)

Another income measure provided by the Census Bureau is "median earnings for full-time year-round workers" broken out by gender. According to the 2008-2010 American Community Survey, the 60010 earnings by gender were \$110,421 for full-time year-round male workers and \$66,923 for female workers.

According to mongabay.com, calculated from IRS data, 60010 is the seventh wealthiest zip code in the country among zip codes with 20,000 income tax returns filed. Also, IRS data for 2011 shows that, among 60010 residents, 21,261 tax returns were filed, for a total adjusted gross income of \$3,989,241,000 and a total tax liability of \$791,905,000. About 55% of the gross income came from salaries and wages.

### Poverty

Fewer 60010 residents live in poverty (4.9%) as a proportion of the population than the state (13.7%) and nation (14.9%), according to the 2008-2012 American Community Survey. However, since the 2000 Census, poverty in 60010 more than doubled from 2.3% in 2000. 60010's poverty rate for children (5.4%) is well below both the state (19.3%) and U.S. (20.8%). However, since the 2000 Census (2.8%), the poverty rate for local children has almost doubled. (Table 8.5)

Poverty rates differ somewhat among races/ethnicities. 60010 Hispanics (16.2%) recorded a 2008-2012 poverty rate over four times higher than the level for white non-Hispanics (3.8%). The poverty level for Asians stood at 9.9%, while local blacks recorded a very low poverty rate of just 2.6%. Poverty for all races/ethnicities, especially blacks, are much lower than seen for Illinois and the nation. (Table 8.6)

About nine of ten (89.4%) 60010 residents have income more than 200% of poverty or twice the poverty level. The 2010 poverty threshold was \$22,113 for a family of four with two children and \$11,139 for a person living alone. (Table 8.7)

In 2013, Medicaid recipients in 60010 totaled 1,597 or 3.6% of the population. Of these, 829 are children.

#### Income and Poverty Characteristics of 60010 Communities

Among the eight 60010 communities covered in this report, South Barrington recorded both the highest median household (\$166,250) and median family (\$163,229) income. Lake Barrington (\$93,213) exhibits the lowest household median, while the lowest family median was seen in Port Barrington (\$120,250). The poverty level for all persons (9.2%) and children (12.2%) was higher in the Village of Barrington than the other communities. (Table 8.8)

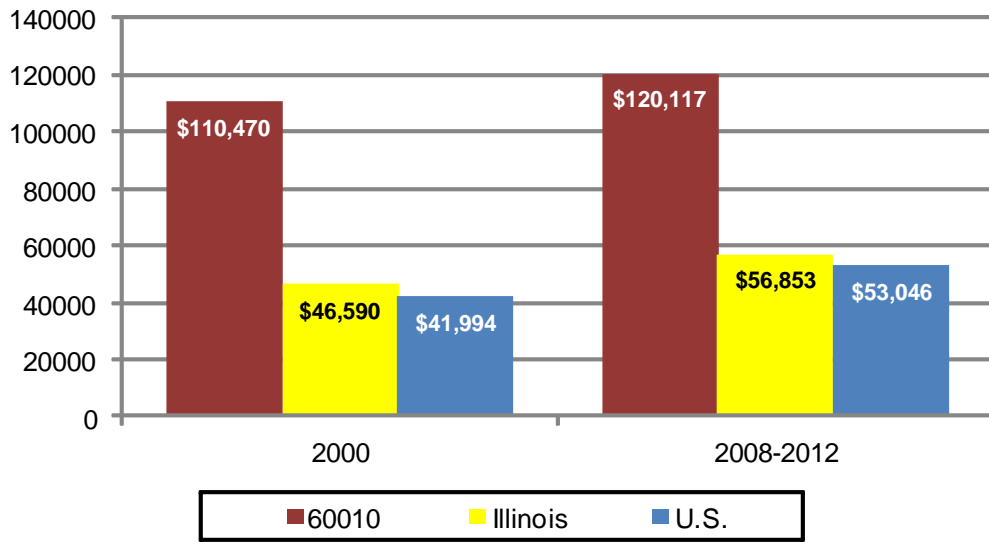

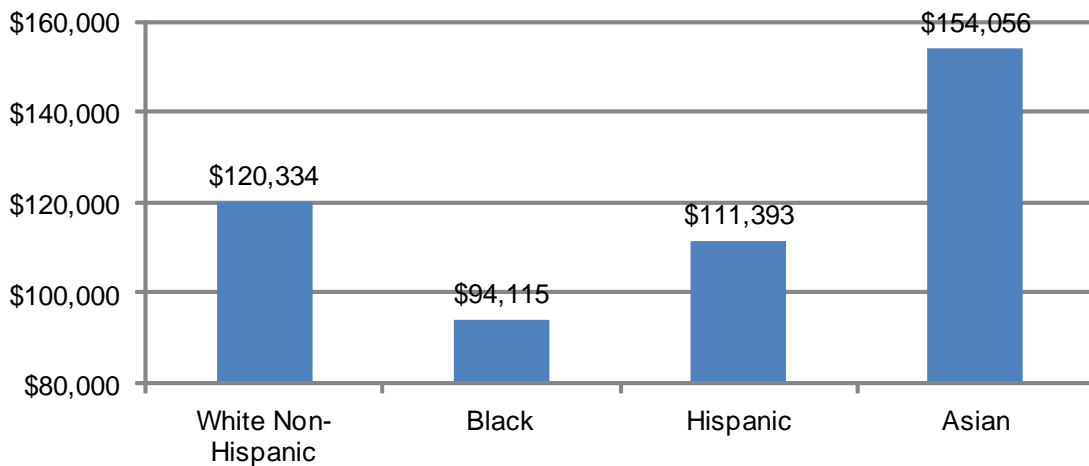

**Median Household Income: 2000 – 2008-2012**

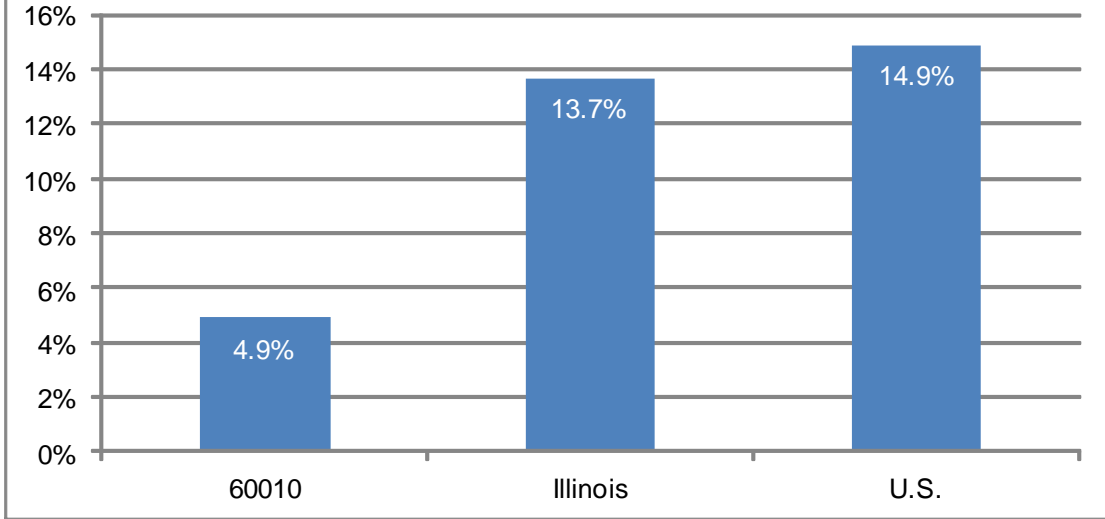


**Figure 8.2**

**Median Household Income by Race/Ethnicity: 2008-2010**

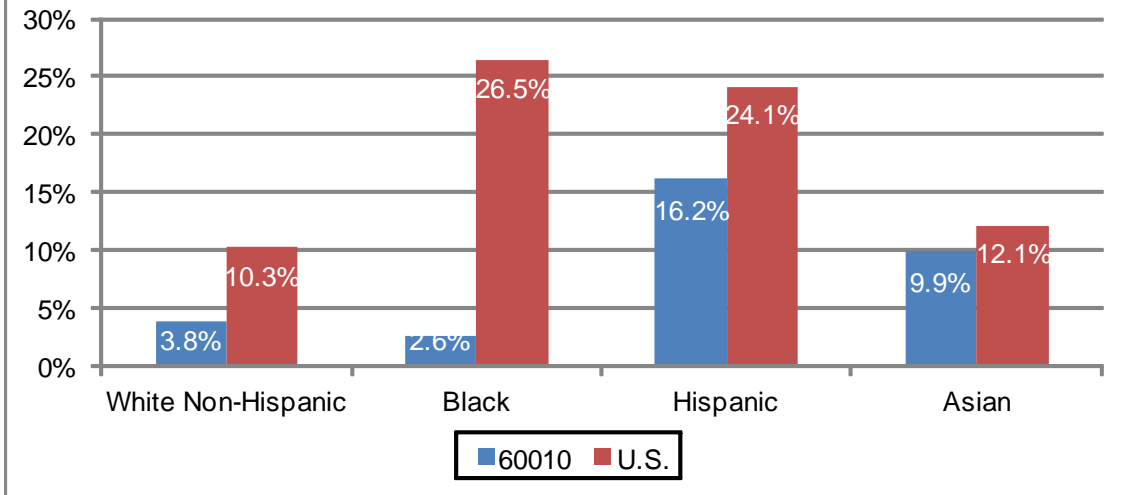




**Figure 8.3**

## Chapter 9 BIRTHS (NATALITY)

### Births, Birth and Fertility Rates

60010 recorded 322 resident births in 2009, 337 in 2008, and 320 in 2007. 60010 birth rates (births per 1,000 population) were consistently below state and national birth rates for all three years. The 2009 60010 birth rate was just 7.3 births per 1,000 population, compared to 14.1 for the state and 13.5 for the nation. (Table 9.1)

The 60010 fertility rate (births per 1,000 females aged 15-44), a more specific measure of birth activity, stood at 51.1 in 2009, down a bit from 53.5 in 2008, but slightly higher than 2007's 50.8. Like the birth rate, 60010's fertility level falls below both the Illinois and U.S. figures. The 2009 rate was lower than the state (64.7) and U.S. (66.7) rates. (Table 9.2)

### Births by Race/Ethnicity and Age

Births in 60010 were predominantly white non-Hispanic during the period 2007 - 2009. In 2009, 82.3% of 60010 births were white non-Hispanic, while Asian non-Hispanic births constituted 11.8% of births. Hispanic births stood at 4.3% while black births accounted for just 1.6% of all births. Race/ethnicity patterns in both 2007 and 2008 were similar to 2009. (Table 9.3)

60010 women giving birth are most likely to be in their thirties. In 2009, over one-third (37%) of 60010 births were to women aged 30-34, while one in three (30.7%) were born to women ages 35-39. The median age of mother locally stood at 33.4 in 2009, much older than the median for Illinois (28.5) and the U.S. (27.9). In 2007, the median age of 60010 mothers was 34.1 years, with 2008's median age being 33.5. (Tables 9.4 and 9.5)

60010 recorded just seven teen births in 2009; however, this is higher than the two teen births in 2007 and five in 2008. Proportionally, 2.2% of 2009 births were to teens, rising from 1.5% in 2008 and 0.7% in 2007. The local teen birth level is substantially below Illinois and the U.S. For 2009, the zip code's 2.2% level compared to 9.6% for the state and 10% for the nation. (Table 9.6)

### Births to Unmarried Mothers

In 2009, about one in eleven (8.7%) 60010 births were to unmarried mothers. The area's proportion of births to unmarried women has consistently fallen far below the state and national levels, which in 2009 stood at 40.6% for Illinois and 41% for the U.S. (Table 9.7)

### Low Birth Weight, Preterm Births, First Trimester Care, and Smoking

Low birth weight is a good indicator of infant health. In 2009, 20 60010 births were of low weight (less than 2,500 grams or five and half pounds) accounting for 6.2% of all births, rising from 4.7% in 2008, but lower than 2007's 7.5%. The 2009 proportion was somewhat lower than Illinois at 8.4% and the U.S. at 8.2%. (Table 9.8)

Another indicator of infant health is gestational period. In 2009, zip code 60010 recorded 23 births (7.1%) with a gestation period of less than 37 weeks (preterm), a lower proportion than the state (12.4%) and nation (12.2%). Data for 2007 and 2008 also indicate a better preterm proportion locally. (Table 9.9)

Good birth outcomes depend, in part, on adequate prenatal care. Ideally, care should begin in the first three months of pregnancy (first trimester). In 2009, over nine in ten (91.9%) 60010 births received first trimester prenatal care, a small improvement from the 2008 level of 87.5%. The 2009 level compares favorably to the Illinois proportion of 82.3%. (Table 9.10)

Certain behaviors during pregnancy can put newborns at risk. Smoking is associated with an increased incidence of low weight birth and congenital anomalies. Mothers self-report these behaviors on the infant's birth certificate so accuracy cannot be assessed. For 2009 births, just 5 (1.6%) of 60010 mothers reported tobacco use during pregnancy, much lower than the state level of 7.8% and national level of 5%. During 2007 and 2008, 1.5% and 1.3% of mothers said they used tobacco, respectively. (Table 9.11)

### Infant Deaths

60010 reported one infant death in each year from 2008 through 2009, translating to a 2009 rate of 3.1 infant deaths per 1,000 live births. 2009's infant death rate was less than half the rate for both the state (6.9) and U.S. (6.5). The 2008 infant death rate locally was 3.0, while the rate for 2007 stood at 3.1. (Table 9.13)

### Births in 60010 Communities

In 2009, the Village of Barrington recorded the highest number of births among the eight communities covered in this report, with 129 births, for a birth rate of 12.5 births per 1,000 population. The only community with a higher birth rate was Port Barrington (13.8). Along with Barrington and Port Barrington, Tower Lakes recorded a 2009 birth rate (7.8) higher than the zip code overall. The other five places showed 2009 birth rates below the zip code, with the lowest being seen by Barrington Hills (2.6). (Table 9.14)

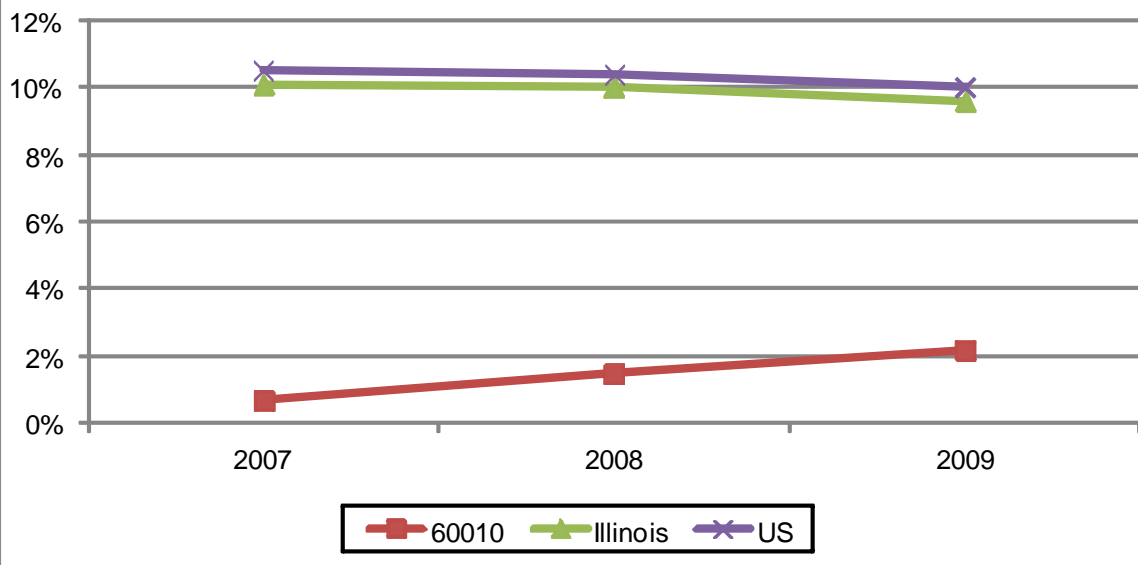

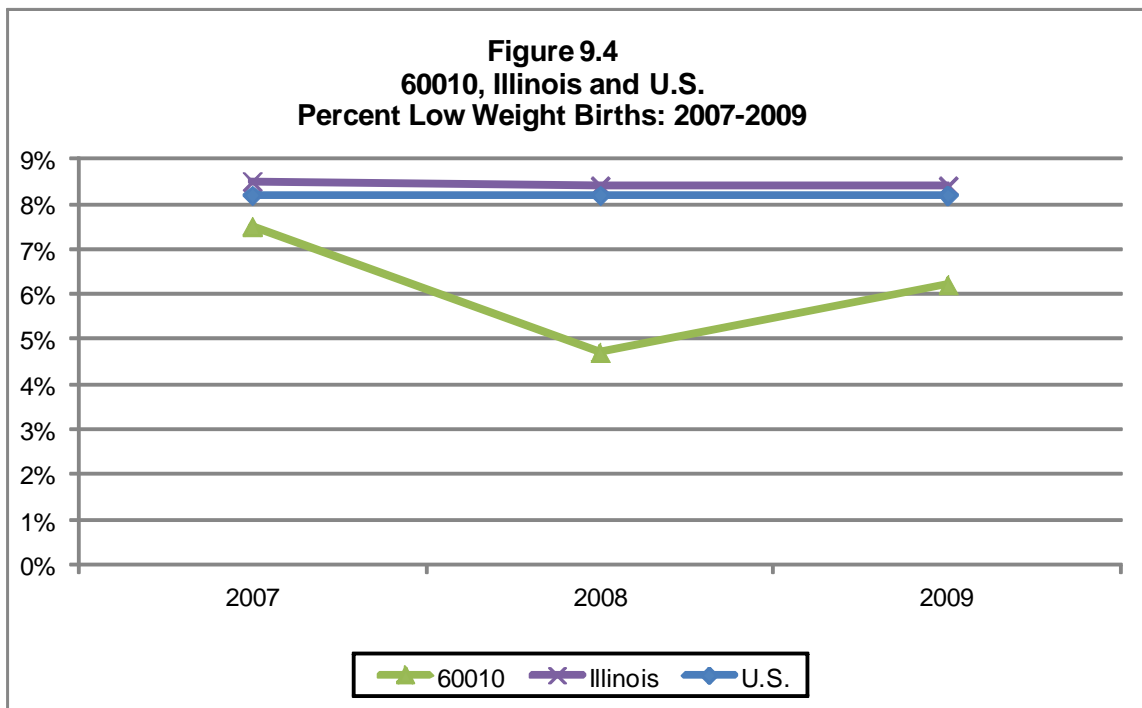




**Figure 9.3**

## Chapter 10 DEATHS (MORTALITY)

### Deaths and Death Rates

Mortality data for 60010 and the major communities were provided by the Illinois Department of Public Health covering 2009 and 2010.

For the two-year period, mortality was 308 in 2009 and 314 in 2010, yielding a two-year total of 622. The 2009-2010 death rate (deaths per 1,000 population) was 7.1, below the U.S. 2010 death rate of 8.0. When the 60010 death rate is age-adjusted to the U.S. 2010 age structure, the rate is even lower at 6.3. (Table 10.1)

### Deaths by Gender, Age, and Race/Ethnicity

As might be expected, deaths are heavily concentrated in the older age groups. More than two-thirds (69.1%) of all 60010 deaths take place among persons aged 75 and older. For the nation in 2010, only 56.4% of deaths were to those aged 75 and older. Death rates in all age groups are lower than for the nation. Especially low are deaths in the 55-64 year-old age group, which are just one-third (34.1%) of the U.S. level. (Table 10.1)

By gender, females (7.2) recorded a slightly higher death rate than males (6.9), although both are well under the national rates. The female population is older than the male, so that a higher rate would be expected. (Table 10.1)

For the two year period 2009-2010, the race/ethnic distribution of deaths was white non-Hispanic (594), Asian non-Hispanic (19), Hispanic (6), and Black non-Hispanic (4). Therefore, 95.3% of deaths involved white non-Hispanic persons. The younger age structure of "minorities" is largely responsible for their low presence in the mortality data.

Death rates reflect the same factors. Compared to the overall death rate (deaths per 1000 population) of 7.1, the race/ethnic specific rates were white non-Hispanic (7.8), Asian non-Hispanic (2.6), Hispanic (2.1), and Black non-Hispanic (5.7). (Table 10.1)

### Deaths by Cause

Death rates in 60010 for all leading causes are similar to the nation. (Table 10.2)

Cancer is the leading death cause in the Barrington area (173 deaths in 2009-2010), followed by heart disease (139 deaths). These two death causes accounted for half (50.2%) of all 2009-2010 deaths. Heart disease appears relatively low, especially for an "older" area. (Table 10.3)

The next most frequent death causes are stroke, chronic lower respiratory disease, influenza/pneumonia, Alzheimer's, and diabetes. (Table 10.3)

### Deaths in 60010 Communities

Among local communities, the Village of Barrington had the highest 2009-2010 death rate at 13.8, followed by Lake Barrington (9.9) and Tower Lakes (8.6). Lowest was Deer Park at 2.7 and North Barrington at 3.0. These rates are not age-adjusted. (Table 10.4)

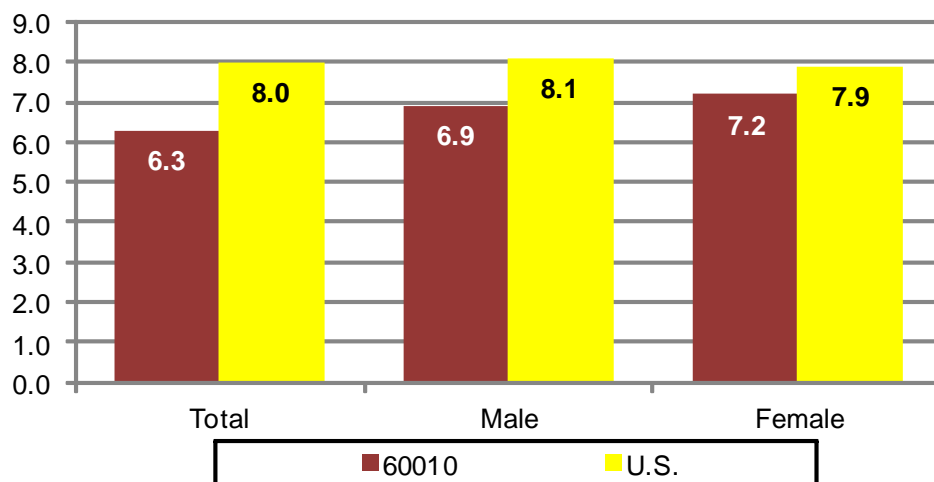

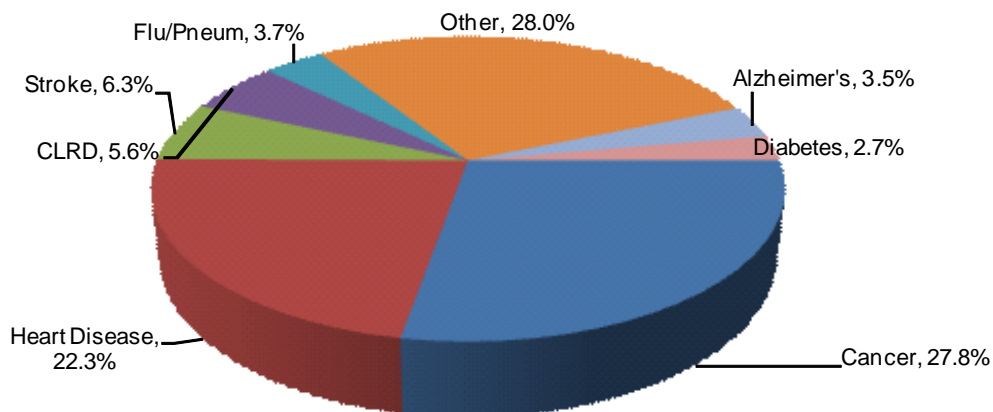

## Chapter 11 HEALTH STATUS AND BEHAVIORS

### Perception of Health

Six of ten (61.2%) 60010 adults aged 18+ consider themselves to be in very good or excellent health according to estimates from the 2009 Behavioral Risk Factor Surveillance Survey. This level is better than the state at 55.1%. Just 1.8% rated their health as poor in 2009. Conducted by the Illinois Department of Public Health, the Behavioral Risk Factor Surveillance Survey (BRFSS) collects information about perceptions, behaviors, health care utilization and prevalence of certain conditions and diseases. Estimates for 60010 are derived from the respective proportions in Lake (63%) and Suburban Cook (37%) Counties. (Table 11.1)

The majority (61.5%) of 60010 adults enjoyed good mental health during all days of the past month in 2009, the same as the state level. At the other end of the spectrum, an estimated 12.4% said they experienced poor mental health for more than one week of the past month. In 2009, 65.4% of 60010 adults perceived their physical health to be good all days of the past month while 11.6% said their physical health was poor for more than seven of the past 30 days. This compares to the state's 13.7% saying poor health extended more than seven of the past 30 days. (Table 11.1)

### Prevalence of Chronic Conditions

Analyzing the magnitude of chronic conditions becomes an important dimension of a community's health profile since these conditions affect the daily capabilities and overall well being of a significant proportion of the population. In the BRFSS respondents indicate the presence of conditions diagnosed by a health professional. Based on these self-reported results, over one-third (35.1%) of local residents have high cholesterol, a bit lower than the Illinois level of 37.3%. Additionally, just under one-fourth of 60010 adults are estimated to have arthritis (23.7%) or high blood pressure (22.3%). The local blood pressure level is better than the state's 29%. The results also indicate that 8.4% of 60010 adults suffer from asthma, while diabetes afflicts 8.9% of the local population. (Table 11.2)

The presence of chronic conditions may also be estimated by applying national prevalence rates to the local population. Using this approach, chronic joint symptoms and hypertension top the list of chronic conditions, each having more than 10,000 individuals with one of these conditions. Lower back pain (9,827) and arthritis (9,053) are next highest in prevalence. When examined by age group, 60010 residents aged 18-44 are most likely to suffer from lower back pain and migraines, while middle-aged adults aged 45-64 most commonly have chronic joint symptoms and hypertension. Hypertension and arthritis occur at higher levels than other chronic conditions among the county's elderly for both those 65-74 and 75+. (Table 11.3)

### Health Behaviors

Over half (54.9%) of 60010 residents are overweight or obese based on body mass index (BMI) calculated from height and weight, a level below the state at 64%. One in five (19.3%) 60010 adults is at risk for binge drinking based on their alcohol consumption, a bit above Illinois' rate of 17.5%. The proportion of local residents who currently smoke is 15.8%, lower than the Illinois proportion of 18.8%. (Table 11.4)



### Cancer Incidence

For the five-year period 2006-2010, 60010's average annual cancer incidence rate stood at 620.5 per 100,000 population. Cancer occurs a bit more often in 60010 men (a rate of 629.2) than women (612.0).

The leading cancer site for men, by far, is prostate (221.4), followed by urinary system (61.8) and lung/bronchus (52.6). For women, invasive breast (184.7) is the leading incidence site, along with breast-in situ (64.2) and lung/bronchus (58.9). Aside from gender specific sites, men reveal higher rates of incidence for most cancer sites. (Table 11.5)

### Special Education Enrollment

During the 2011-2012 school year, a total of 1,361 Barrington School District students were receiving special education services. The largest categories of student exceptional characteristics are speech/language impairment (28.7%) and specific learning disability (23%). Other health impairment (15.1%), developmental delay (12.2%) and emotional disability (10.7%) round out the top five characteristics. The District enrollment was 9,008 so that 15% of students had IEPs. Statewide, the proportion was 13.8%. (Table 11.6)

### Mental Disorders

Within the past year, at least 3,875 local residents aged 18-54 can be estimated to have been affected by a mental disorder using rates found in the 1999 *Mental Health: A Report of the Surgeon General*, as applied to the estimated 2010 age structure of 60010. The leading mental disorders are any anxiety disorder (16.4%) and any mood disorder (7.1%). An estimated 2,815 local residents aged 55 and older have a mental disorder. Rates are slightly lower for this age group than for those aged 18-54, with the exception of cognitive impairment, which affects 6.6% of this age group. The annual prevalence of mental disorders in children and adolescents is not yet well documented for ages 9-17, but the levels are thought to be similar to adults. (Table 11.7)

### Estimated Illicit Drug Use

The National Household Survey on Drug Use and Health measures the prevalence of the use of illicit drugs, prescription drugs used nonmedically in the U.S. civilian, noninstitutionalized population 12 years old or older. The number of persons aged 12 and older currently using illicit drugs based on 2010 population in 60010 is estimated to be about 2,728. Marijuana is the primary illegal substance used, an estimated 1,981 persons, followed by illicit use of psychotherapeutic drugs (889). By age group, 466 youth aged 12-17 are estimated to currently use an illegal drug, with 517 persons aged 18-25, and 1,746 aged 26 and older. By gender, the number for 60010 males stands at 1,859, while 1,168 women currently are estimated to be using an illicit drug. These figures assume that the Barrington area has use rates similar to the nation. (Table 11.8)

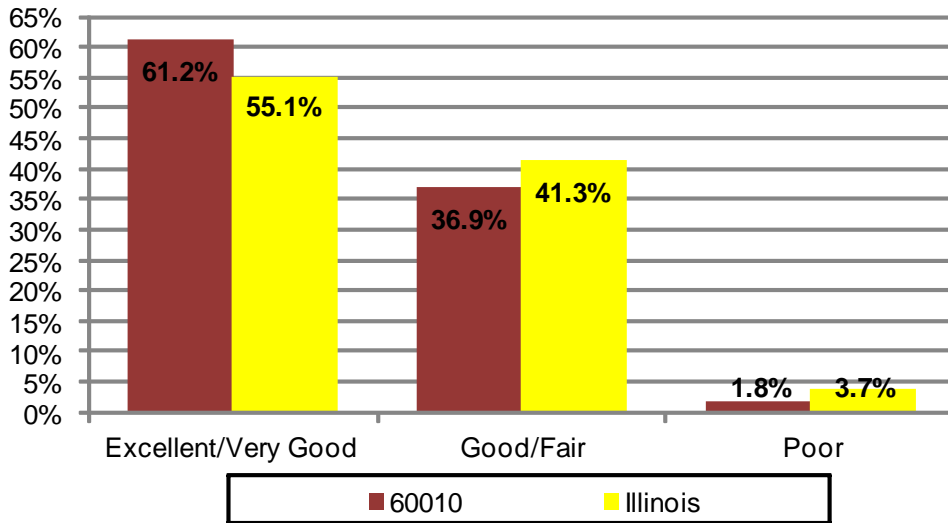

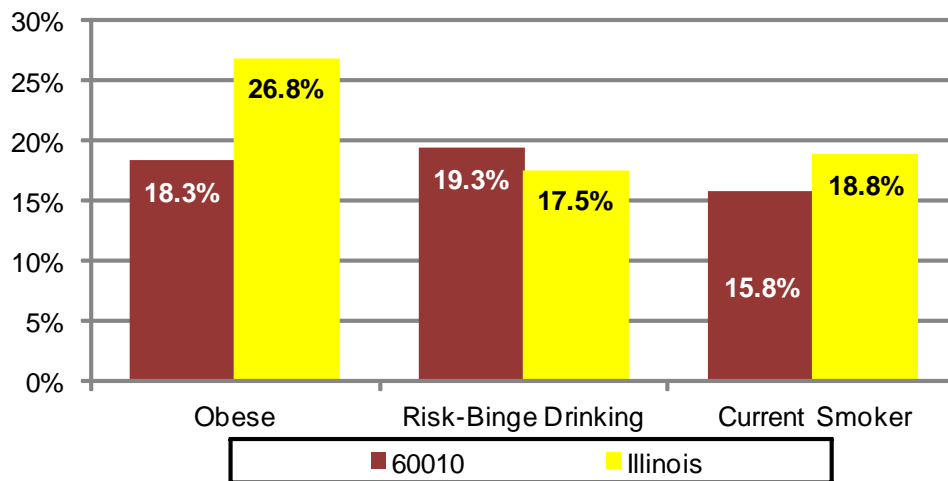

## Chapter 12 HEALTH RESOURCES AND UTILIZATION

### Health Insurance and Health Care Use

Based on estimates for 60010 derived from Lake/Suburban Cook results from the 2009 Illinois Behavioral Risk Factor Survey, 92.1% of residents have health plans and 74.5% are covered by dental plans, both well above statewide figures. (Table 12.1)

Those who did not graduate high school (28.9%), Hispanics (20.6%), and the unemployed (18.2%) are most likely to lack medical coverage. (Table 12.2)

According to 60010 estimates, 16.6% of the adult population report not being able to afford the dentist in the past year, 7.9% avoided the doctor due to cost and 8.4% did not get their medications because of cost. (Table 12.1)

### Hospitalization

Based on 60010 hospitalization discharge data for the most recent year available from the Illinois Hospital Association provided by Advocate Good Shepherd Hospital, hospital inpatient admissions were 785.8 per 10,000 residents in 2012-2013, one-third lower than the U.S. 2010 rate. 60010 women are hospitalized 16.9% more often than men, with obstetrics being a primary reason. Residents aged 65+ are hospitalized five times more often than those younger than 65. Data is for twelve months covering 4<sup>th</sup>Q 2012 through 3rdQ 2013. (Table 12.3)

Hospitalization is lower than the nation for both genders and all age groups, with 60010 residents aged 45-64 being hospitalized at only half the U.S. rate. 60010 residents generated \$149.2 million in hospital charges during the twelve-month study period, with the average stay of 4.5 days costing \$39,552. Stays become more costly with increasing age. (Tables 12.3 and 12.4)

Aside from cases related to newborns and delivery, the leading DRGs for hospitalization are major joint replacement (primarily hip, knee) with 221 discharges and psychoses (162). Fifty cases or more were generated for 60010 residents for digestive disorders (76), septicemia (67), substance abuse without rehab or major complications (53), cellulitis (51) and rehabilitation with complications (50). (Table 12.5)

Hips and knees, along with other major joint replacements, yielded the highest charges among the top 25 DRGs, \$11.1 million, an average of \$50,443 per case. PCTA (\$77,111), rehabilitation (\$67,968), septicemia (\$60,870), and pneumonia (\$55,649) have even higher average charges. (Table 12.5)

Newborn dominate 60010 hospitalizations for those under age 5. Psychoses is the leading hospitalization reason for those aged 5-14 and aged 15-44 (other than delivery). For residents aged 45-64, the top three discharge reasons are major joint replacement, psychoses, and digestive disorders. Among persons aged 65+, major joint replacement, septicemia, rehabilitation, and heart failure are the leading inpatient reasons. (Tables 12.6 - 12.10)

Women are admitted twice as often as men for digestive disorders. (Tables 12.11 - 12.12)

### Health Manpower

State licensure address data for health professionals living or working in 60010 reveal that Registered Nurses (591) and physicians (398) are the most common health occupations. Present at twice the state rate are physicians and dentists. The area has far fewer pharmacy technicians and LPNs than the state as a whole. (Table 12.13)

### Health Facilities

60010 contains one community hospital (Advocate Good Shepherd), two nursing homes (Alden Estates and Prairieview at Garlands), one ambulatory surgery facility (Barrington Pain and Spine), and two renal dialysis facilities (ARA and Barrington Creek). Also located within 60010 are three assisted living facilities (Lake Barrington Woods, Prairieview at The Garlands, and Sunrise), two hospices (Journeycare and Monarch), plus five home health/home service agencies. 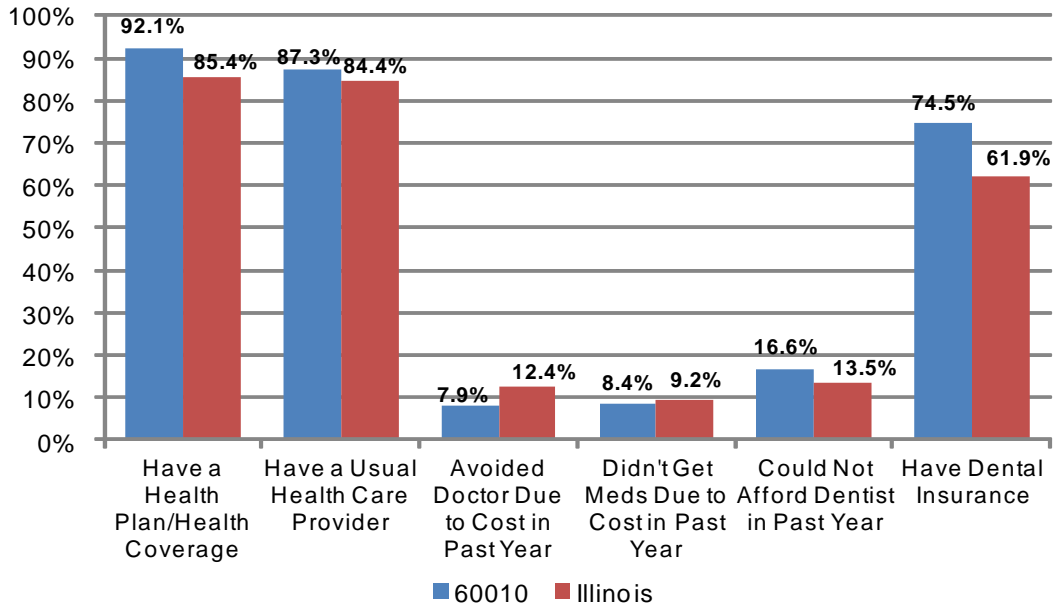

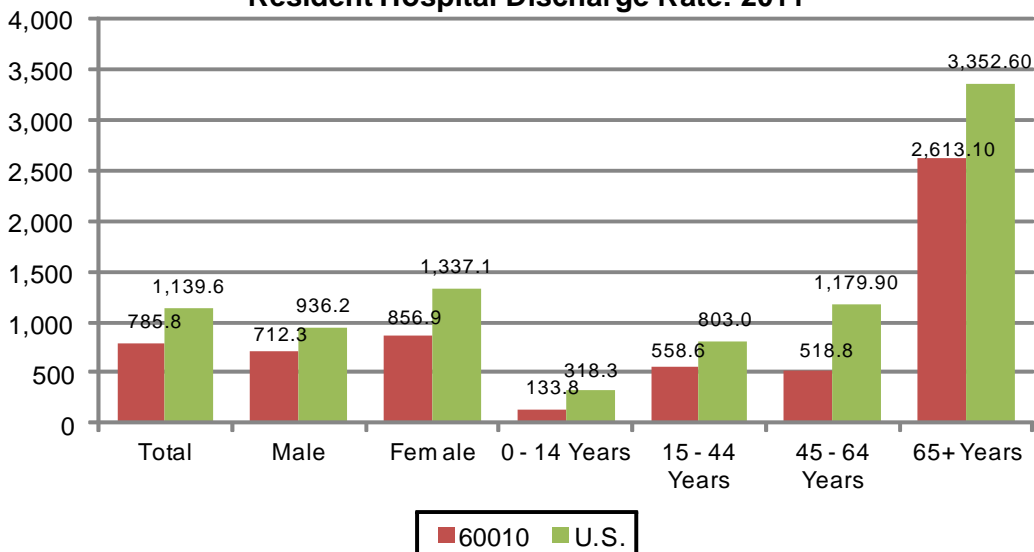

## Chapter 13 CRIME AND VIOLENCE

### Crime Rate

A geographic area's crime rate (per 100,000 population) is based on the occurrence of eight Crime Index crimes, which are defined by the national Uniform Crime Reporting (UCR) program. Four of the index crimes in the UCR program are violent crimes – criminal homicide, forcible rape, robbery, and aggravated assault/battery; while the other four are property crimes – burglary, larceny/theft, motor vehicle theft, and arson. Zip code crime data is not readily available. Of the eight communities covered in this report, crime data was able to be obtained for five: Barrington, Barrington Hills, Deer Park, South Barrington, and Tower Lakes.

All five of the communities for which data was available experienced very low crime rates in 2011. The lowest rate was recorded in Tower Lakes (543.9 index crimes per 100,000 population), followed by Barrington Hills (941.9). For comparison, the Illinois 2011 crime rate stood at 3,073.1. Although still low, the highest rate among the five communities was recorded by South Barrington (1,659.8), followed by Barrington (1,486.8). Violent crime in the five communities in 2011 was extremely low, with four forcible rapes in Barrington and two aggravated assaults in South Barrington. (Table 13.1)

Just one of the five communities showed a one-year increase in crime from 2010 to 2011. The crime rate in Barrington rose by 18.9% from 1,250.0 in 2010 to 1,486.8 in 2011. All of the other communities recorded a decline in their crime rates, with the largest drop seen by Tower Lakes (-35.5%). (Tables 13.1 and 13.2)

### Domestic Violence

A Safe Place is the sole provider of services exclusively addressing domestic violence in Lake County. During FY2012, A Safe Place served 2,655 clients. Of these, 2,217 (83.5%) were adult victims. The agency received 3,379 crisis calls and provided 7,519 nights of shelter. They also assisted with 1,636 orders of protection. Breakouts are not available for the Barrington area. (Table 13.3)

### Elder Abuse

Illinois maintains an extensive system to prevent the abuse of older persons (aged 60+). The Adult Protective Services Program of the Illinois Department on Aging is coordinated locally by designated provider agencies. Catholic Charities is the designated agency for the 60010 portions of Cook and Lake Counties. Data was obtained only for Barrington Township which, in the period 7/1/12 – 6/30/13, recorded just three elder abuse clients. Barrington Township (2010 pop: 15,636) covers about one-third of the 60010 population.

### Child Abuse

During FY2010, reports of child abuse in 60010 numbered 62, a rate of 5.4 per 1,000 children aged 0-17, well below the Illinois rate of 29.6. Reports of abuse are not always found to be deserving of investigation, and many are not found to be indicated when investigated. Indicated means that sufficient credible evidence has been found to support an abuse/neglect claim. During FY2010, of the reported 60010 cases, 12 (19.4% of reported) were indicated, for a rate of just 1.0, much lower than the state indicated rate of 8.3. Both the number and rate of child abuse locally dropped from FY2009, when the reported rate stood at 9.2, while the indicated rate was 1.8. (Table 13.4)

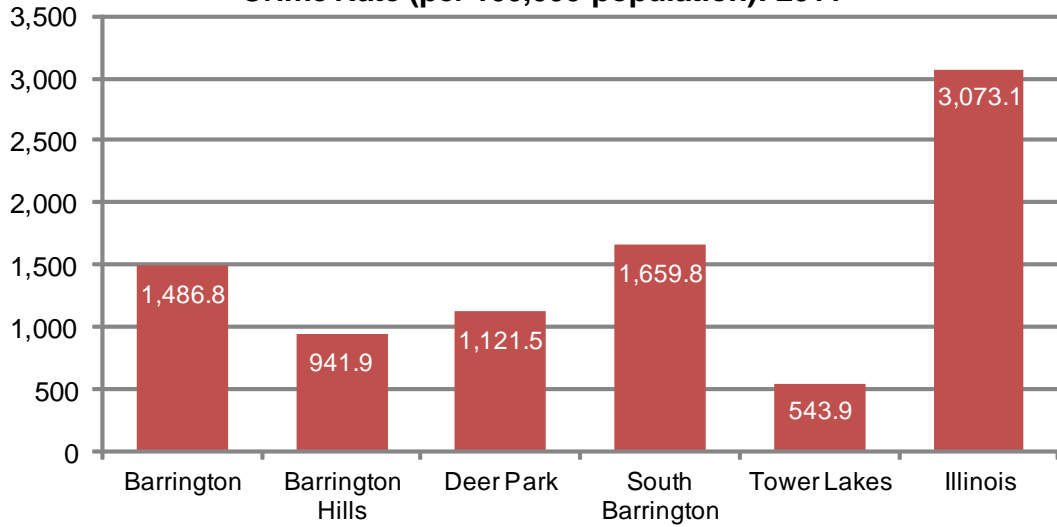
