Chapter 1 INTRODUCTION

The Barrington Area Community Analysis presents a comprehensive overview of ZIP code 60010, describing residents and resources through secondary sources of information.


Topics in the Community Analysis include population size, age, race/ethnicity, gender, family structure, income and poverty, education, employment, housing, births, deaths, health status including morbidity, health behaviors, disability, health resources, health care utilization, social indicators, and crime and violence.

The major sources of information for the Community Analysis are the 2020 American Community Survey 5-year estimates, other U.S. Census updates, vital statistics collected by the Illinois Department of Public Health, Behavioral Risk Factor Survey, and social and economic indicators primarily from state and regional agencies.

The Barrington Area Community Analysis relies quite heavily upon recent data from the American Community Survey (ACS), 2020 Decennial Census and Metopio. Historically, the Census Bureau has collected detailed demographic, housing, social and economic data every ten years, selecting a sample of one in six households to complete the detailed "long form." Desiring more timely information, the Census Bureau has replaced the decennial "long form" used in 2000 with the ACS, which collects the same type of data every year. Three million households across the nation are surveyed annually, using a multi-stage sampling technique and a varying percentage of households depending on an area's size. Because the sample is limited, years are combined for greater reliability. This report primarily relies on 2020 data for 60010, reflecting the most recent data.

This report was prepared for the Healthier Barrington Coalition, a partnership of 25 Barrington Area organizations working together to improve the quality of life for residents of the Barrington Area. The Coalition has regularly conducted assessments of needs every five years. This community analysis adds further depth to understanding the Barrington Area community.

Chapter 2 POPULATION

Introduction

Census Bureau ZIP codes used in this report are actually ZIP Code Tabulation Areas (ZCTAs), first developed by the Census Bureau for tabulations in 2000. They differ slightly from U.S. Postal Service ZIP codes which change boundaries regularly. Barrington also hosts ZIP code 60011 for post office boxes.

Population Characteristics

The 2016-2020 American Community Survey of all 60010 residents yielded an estimate of 46,326. This is a population increase by 2,231 since 2010. (Table 2.1)

- Population Size
 - Barrington is the largest village in the 60010 ZIP code with a 2020 estimated population of 10,722.
 - Somewhat less populated are Lake Barrington (5,100), South Barrington (5,077) and Barrington Hills (4,114), followed by Deer Park (3,681) and North Barrington (3,171). Smaller are Port Barrington (1,584) and Tower Lakes (1,226). (Table 2.2)
- Population Gain
 - From 2010 2020, ZIP code 60010 grew 5.1% from 44,095 to 46,326. (Table 2.1)
 - Every village in the ZIP code experienced a population increase since 2015.
 - In terms of percentage, Barrington Hills (22.1%), Deer Park (10.8%) and Port
 Barrington (9.2%) had the highest population increases since 2015. (Table 2.2)
- Physical Characteristics
 - Entirely within 60010 are Barrington, Barrington Hills, Deer Park, North Barrington, Port Barrington, South Barrington, and Tower Lakes. Lake Barrington addresses are 96.3% in 60010. Smaller proportions of Inverness, Lake Zurich and Hoffman Estates are also within 60010. (Table 2.3)




Chapter 3 AGE AND GENDER

<u>Age</u>

- Median Age and Age Increase
 - The 60010 median age in 2020 was 46.7 years, which is older than the Illinois median age of 38.3 years. Locally the median age rose a little less than 1 year from 2010 to 2020. (Table 3.1)
 - The age groups with the highest population in 60010 are 55-59 years (10.2%), 50-54 years (8.7%), and 10-14 years (8.1%) (Table 3.2)
- > Age for 60010 Communities
 - The youngest median age among 60010 communities is found in Port Barrington (38 years), while the community with the oldest median age is Lake Barrington (55.8 years). Lake Barrington, by far, had the highest percentage (33.2%) of seniors aged 65+, followed by Barrington Hills (24.7%). The communities with the highest percentage of residents are South Barrington (28.7%), Port Barrington (27.2%) and Tower Lakes (27.1%). (Table 3.3)
- ➤ Gender
 - Overall, ZIP code 60010 contains 22,431 males and 23,895 females. (Table 3.4)



PERSONS BY AGE GROUP: 2020					



Chapter 4 RACE, ETHNICITY, LANGUAGE, ANCESTRY

Race/ Ethnicity

- Racial Groups Size
 - Those identifying as White was the largest racial group in the 60010 ZIP code, accounting for 80.9% of the population.
 - The second largest racial group was Asian, accounting for 14% of residents.
 Other categories total less than one percent, while 1.9% of residents named more than one race. (Table 4.1)
- Hispanic Population
 - Hispanic is considered an ethnic identity by the Census Bureau, not a race. The term Hispanic was first adopted for the 1980 Census.
 - The 2020 Hispanic count stood at 1,837 residents, which is 4% of the population. (Table 4.1)

<u>Language</u>

- Language Spoken
 - The 2016-2020 ACS asked persons aged five and older whether they speak a language at home other than English. Of the 44,195 Barrington area residents aged 5+, 79.7% (35,215 persons) speak only English at home, 20.3% (8,980 persons) speak some other language at home. (Table 4.2)

Chapter 5 HOUSEHOLD CHARACTERISTICS AND MARITAL STATUS

<u>Household</u>

- Household Structure
 - In 2020, the number of 60010 households stood at 16,683. (Table 5.1)
 - Married couple households (70%) comprise a majority of the households, while male householder with no wife present (8.5%) and female householder with no male present (518.7%) have both increased since the last Barrington Study. (Table 5.1)
 - The average household size in 60010 was 2.76 persons, slightly higher than the state (2.54) average. The average family has 3.12 persons, which is slightly lower than the state (3.20) average. (Table 5.1)
 - The average household size has decreased in the last 20 years from 2.84 to 2.76 from 2000 to 2020. The average family size has also decreased from 3.18 to 3.12 from 2000 to 2020. (Table 5.2)

Household Settings for Children

- > Children
 - Almost nine in ten (85.8%) of 60010 children under age 18 lived in a married couple family in 2020. Living with a single female parent are just 10.1% of local children, while 3.8% of the children reside with a single male parent. (Table 5.3)

Marital Status

- Marital Status of Persons 15+
 - Among 60010 residents aged 15 and older, 65% are now married, 20.4% are never married, 7.3% divorced, 1.8% separated, and 5.6% widowed. (Table 5.4)



Chapter 6 HOUSING

Housing Characteristics

- Units and Occupancy
 - In 2020, 60010 contained 17,864 housing units, of which 93.4% were occupied and 6.6% were vacant. (Table 6.1).
- Mortgage and Renting Costs
 - The median value of owner-occupied units, for 60010 residents in 2011-2015 was \$542,300. (Table 6.2)
 - The median gross rent in 60010 for 2016-2020 was \$1,838. (Table 6.3)
 - Just under 2/3 of the owner-occupied houses have a current mortgage (62.8%), while the other 1/3 are without a mortgage (37.2%). (Table 6.4)
- Other Housing Characteristics
 - Almost half of all households have two vehicles available (45.2%), followed by households with three or more vehicles available (31.3%). Only 3.5% of households have no vehicles available. (Table 6.5)
 - A majority of homes are heated by utility gas (85%), followed by electricity (13.4%). (Table 6.6)





Chapter 7 EDUCATION AND EMPLOYMENT

Education

- Educational Attainment
 - Bachelor's degrees have been obtained by 40.2% of 60010 residents, much higher than the state (21.6%). More than one-fourth (28.5%) of residents hold a graduate or professional degree, far above the Illinois rate (13.9%). (Table 7.1)
- Graduation and Enrollment
 - Four-year high school graduation rates for the Barrington School District are 95.2%, well above the state (86.5%) for recent years. (Table 7.2)
 - Overall private school enrollment for the population aged 3+ is 17.2%, similar to the Illinois proportion of 18.9%. Private school enrollment, in 60010, is highest for preschool (63.4%) and graduate school (70%). (Table 7.3)

Employment


- Work Participation and Characteristics
 - A majority of 60010 residents are in the labor force (59.9%), while only 1.9% are unemployed. (Table 7.4)
 - Among 60010 families (two or more related persons living together), 84.2% are married couples. In just under half (49.8%) of married couple families, both the husband and wife are in the labor force; 27.1% have the husband in the labor force, 5.9% have just the wife in the labor force, while in 17% neither is in the labor force. (Table 7.5)
- ➢ Commute
 - The commute time for 2016-2020 is at 34.6 minutes for workers living in 60010, compared to Illinois at 29 minutes. In 60010, 16.7% of workers spend an hour or more traveling to work. There are somewhat higher levels of residents who work from home (15.3%) as compared to Illinois (7.2%). (Table 7.7)

Business Characteristics

- Occupation and Industry
 - In terms of occupation, 61.2% of 60010 workers classify themselves as "management, business, science, and arts occupations". (Table 7.10)

Chapter 8 INCOME AND POVERTY

<u>Income</u>

- Median Incomes
 - The 2016-2020 ZIP code 60010 median household income (\$146,505) was more than double the median for Illinois (\$68,428). From the 2011-2015 ACS to 2016-2020, the median household income for 60010 rose 17.8%. (Table 8.1)
 - Local households headed by 45–64-year-olds earned the most in 2015-2020 (\$179,143). (Table 8.2)
 - Among ethnic groups, the 2016-2020 median household income was highest for Asian households, standing at \$186,259. (Table 8.2)
 - 60010 families earn a median income (\$171,028) far higher than nonfamily households (\$51,432). Median income levels for all household types in 60010 are far above Illinois. The median income in 60010 for married-couple families (\$186,295) is more than double that for single female families (\$80,045). (Table 8.3)
 - Analysis of 60010 household types distributed by income categories shows that the largest proportion of both households (33.2%) and families (39.4%) earn in the \$200,000+ category. (Table 8.4)

<u>Poverty</u>

- ➢ 60010 and Illinois Poverty Rates
 - Fewer 60010 residents live in poverty (3.7%) as a proportion of the population than the state (12%), according to the 2016-2020 American Community Survey.
 - 60010's poverty rate for children (3.1%) is well below the state (16.2%). (Table 8.5)
 - In 60010, females have a higher poverty rate (4.3%) compared to males (3%).
 Poverty rates differ somewhat among races/ethnicities. 60010 Hispanics recorded a poverty rate at 16.2%. (Table 8.5)
 - Education made a substantial difference in the poverty rates. Residents with less than high school graduation (11.4%) and high school graduates (7.3%) had much higher poverty rates than those with some college (3.9%) and those with a Bachelor's degree or higher (3.8%). (Table 8.5)

Income and Poverty Characteristics of 60010 Communities

➢ 60010 Communities

Among the eight 60010 communities covered in this report, North Barrington recorded both the highest median household (\$197,188) and median family (\$210,521) income. Lake Barrington (\$105,651) exhibits both the lowest household median and family median income (\$144,539). (Table 8.6)

Chapter 9 HEALTH

Health Insurance Coverage

- Health Insurance Characteristics
 - In 2020, 97.5% of residents in 60010 have health insurance coverage. Females and males have the same exact health insurance coverage rate at 97.5 percent. (Table 9.1)
 - The age group with the highest unsured rate in 60010 is the 19-25 year old at 4.4%. (Table 9.1)
 - Education is a significant factor in terms of having health insurance coverage. Of adults 25+ years, those with less than a high school diploma have the highest uninsured percentage (25.4%). Those with a Bachelor's degree or higher have the lowest uninsured percentage (.9%). (Table 9.1)

Disabilities

- Disability Characteristics
 - 3,326 residents report to have a disability, making up 7.2% of the 60010 population. (Table 9.2)
 - The majority of individuals with disabilities are older age groups, at 65-74 years (13%) and 75+ years (32.6%). (Table 9.2)

<u>Cancer</u>

- Cancer Incidence
 - For the period of 2010-2014, the leading cancer site by count is Breast-invasive (243), followed by Prostate (191) and Lung/Bronchus (161). (Table 9.3)

ED and Hospitalizations Rates

- Leading ED and Hospitalization Rates
 - Cardiovascular Disease- In the 60010 ZIP code, there are 207.33 ED visits per 100,000 residents due to hypertension, which is much higher than the heart failure rate at 37.7 ED visits per 100,000 residents. The rates for hospitalizations are higher at 610.83 hospitalizations per 100,000 residents for hypertension and 251.03 hospitalizations per 100,000 residents for heart failure. (Table 9.4)
 - Unintentional Falls- The unintentional fall rate for ED visits is 1,795.56 ED visits per 100,000 residents, while the hospitalizations rate is lower at 610.83 hospitalizations per 100,000 residents. (Table 9.5)

- Diabetes- For diabetes, the ED rate is 54.56 ED visits per 100,000 residents and hospitalizations, it is slightly higher at 66.64 hospitalizations per 100,000 residents. (Table 9.6)
- Respiratory Diseases- In the 60010 ZIP code, the rates for COPD are 69.88 ED visits per 100,000 residents and 117.71 hospitalizations per 100,000 residents. The asthma rates in the ZIP code are 75.85 ED visits per 100,000 residents and 18.81 hospitalizations per 100,000 residents (Table 9.7)
- Mental Health- The mental health substance abuse rate is 639.56 ED visits per 100,000 residents. The ED mental health rates are highest for 18–39-year-olds, females and those that are non-Hispanic blacks. (Table 9.8) The hospitalization rate for mental health is 282.22 hospitalizations per 100,000 residents. Groups with the highest rates are 18–39-year-olds and females. (Table 9.9)
- Substance Abuse- In 60010, the substance abuse rate is 446.43 ED visits per 100,000 residents. Also, 18–39-year-old have the highest rates compared to other ages and males have higher rates of ED visits than females. (Table 9.10) The hospitalization rate for substance abuse is 193.32 hospitalizations per 100,000 residents. The hospitalization rates are highest for males and those aged 18-39 years old. (Table 9.11)
